A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, ACCEPTING CERTAIN ONE-FOOT BARRIER STRIPS WITHIN TRACT NO. 6070-1 (WHICH BARRIER STRIPS ADJOIN TRACT NO. 6070-2) FOR STREET PURPOSES TO BE KNOWN AS PORTIONS OF SALISBURY DRIVE, NEPTUNE DRIVE AND BAFFIN DRIVE.

BE IT RESOLVED by the City Council of the City of Riverside, California, that the following one-foot barrier strips are hereby accepted to public use for street purposes to be known as portions of Salisbury Drive, Neptune Drive and Baffin Drive:

Lot "G" (Salisbury Drive), Lot "H" (Neptune Drive), and Lot "I" (Baffin Drive) of Tract No. 6070-1, as shown by map on file in Book 83 of Maps, at pages 41 through 44, inclusive thereof, Records of Riverside County, California.

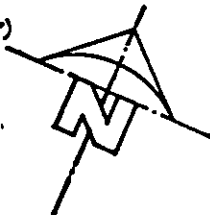

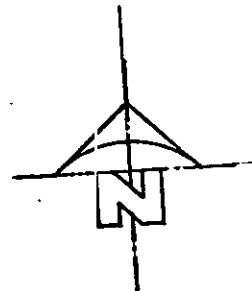
