

RESOLUTION NO. 12810

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, ACCEPTING CERTAIN ONE-FOOT BARRIER STRIPS WITHIN TRACT NOS. 5528, 5104-2 AND 5104-3 (WHICH BARRIER STRIPS ADJOIN TRACT NO. 5104-5) FOR STREET PURPOSES TO BE KNOWN AS PORTIONS OF ALTADENA DRIVE, FARRIER AVENUE, ADLER PLACE AND RUTLAND AVENUE.

BE IT RESOLVED by the City Council of the City of Riverside, California, that the following one-foot barrier strips are hereby accepted to public use for street purposes to be known as portions of Altadena Drive, Farrier Avenue, Adler Place and Rutland Avenue:

Lot "A", a one-foot barrier strip.

Parcel No. 3

In the City of Riverside, that portion of Tract No. 5104-2, as shown by Map on file in Book 82 of Maps, Pages 52 and 53, Records of Riverside County, California, described as follows:

Lot "B", a one-foot barrier strip.


Parcel No. 4


