A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, CHANGING THE NAME OF A PORTION OF CASA BLANCA STREET TO RAILROAD AVENUE.

BE IT RESOLVED by the City Council of the City of Riverside, California, pursuant to the recommendations of the Planning Commission of the City of Riverside that the name of a portion of Casa Blanca Street described as follows:

That portion of Casa Blanca Street as shown by map of The El Grande Tract, on file in Book 5 of Maps, at Page 174 thereof, Records of Riverside County, California, lying northeasterly of the southeasterly prolongation of the northeasterly line of Jefferson Street as shown by said map, and lying southwesterly of the southwesterly prolongation of the northwesterly line of Lot 6 of said map of The El Grande Tract,

be changed to RAILROAD AVENUE.
