A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, ACCEPTING CERTAIN ONE-FOOT BARRIER STRIPS WITHIN TRACT NO. 2740 (WHICH BARRIER STRIPS ADJOIN TRACT NO. 7499) FOR STREET PURPOSES TO BE KNOWN AS PORTIONS OF DELLVALE PLACE, SIERRA GLEN DRIVE AND AINSDALE WAY.

BE IT RESOLVED by the City Council of the City of Riverside, California, that the following one-foot barrier strips are hereby accepted to public use for street purposes to be known as portions of Dellvale Place, Sierra Glen Drive and Ainsdale Way:

Lots "I" and "J" (1' barrier strips) of Tract No. 2740, as shown by map on file in Book 50 of Maps, at pages 71 through 73 inclusive thereof, and Lot "H" (1' barrier strip) of Tract No. 3761, as shown by map on file in Book 58 of Maps, at pages 71 and 72 inclusive thereof, both Records of Riverside County, California;

Said barrier strips were accepted to deny access from adjoining property by Resolution No. 12177 of the City Council of the City of Riverside, California, recorded August 20, 1973, as Instrument No. 109204 of Official Records of said Riverside County.

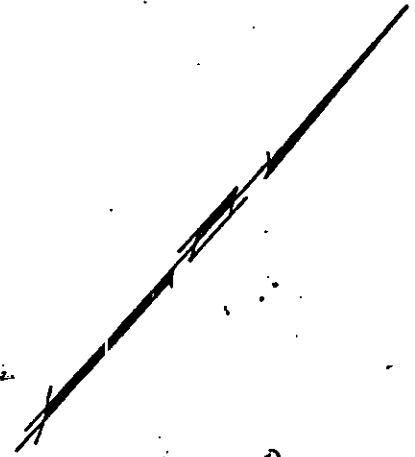

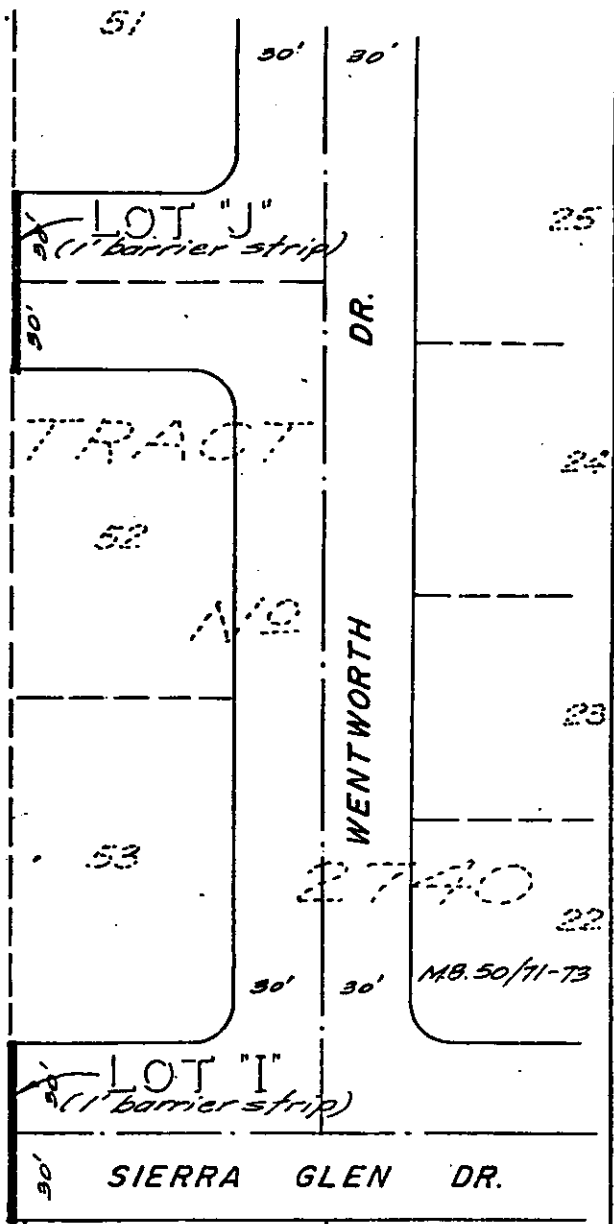

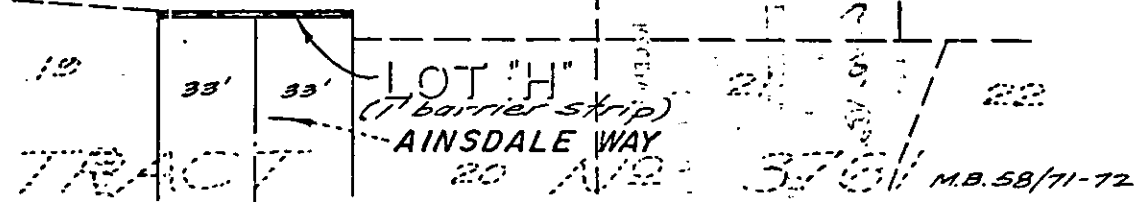


PARCEL 3
