A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, MAKING ITS ORDER VACATING A PUBLIC UTILITIES EASEMENT OVER A PORTION OF LOT 39 OF BELVEDERE HEIGHTS NO. 2, AS SHOWN BY MAP ON FILE IN BOOK 31 OF MAPS, AT PAGE 83 THEREOF, RECORDS OF RIVERSIDE COUNTY, CALIFORNIA.

WHEREAS it appears that the City of Riverside has a public utility easement over a portion of Lot 39 of Belvedere Heights No. 2, as shown by map on file in Book 31 of Maps, at Page 83 thereof, records of Riverside County, California; and

The Easterly 5.00 feet of the Southerly 127.00 feet of Lot 39 of BELVEDERE HEIGHTS NO. 2, as shown by map on file in Book 31 of Maps, at Page 83 thereof, records of said Riverside County.

IT IS FURTHER ORDERED that the City Clerk of the City of Riverside shall cause a certified copy of this resolution and order, attested by the City Clerk under the seal of said City, to be recorded in the office of the County Recorder of Riverside County, California.

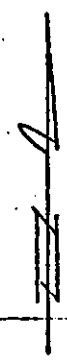
