A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, ACCEPTING CERTAIN ONE-FOOT BARRIER STRIPS WITHIN TRACT NO. 6756-1 AND TRACT NO. 6756-2 (WHICH BARRIER STRIPS ADJOIN TRACT NO. 6756-3) FOR STREET PURPOSES TO BE KNOWN AS PORTIONS OF WALTON STREET, CONGRESS DRIVE AND GWINNETT DRIVE.

BE IT RESOLVED by the City Council of the City of Riverside, California, that the following one-foot barrier strips are hereby accepted to public use for street purposes to be known as portions of Walton Street, Congress Drive and Gwinnett Drive:


Parcel 2
