A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, ACCEPTING CERTAIN ONE-FOOT BARRIER STRIPS WITHIN TRACT NO. 6537-1 AND TRACT NO. 6537-2 (WHICH BARRIER STRIPS ADJOIN TRACT NO. 6537) FOR STREET PURPOSES TO BE KNOWN AS PORTIONS OF TYLER STREET, JURUPA AVENUE AND IDYLLWILD LANE.

BE IT RESOLVED by the City Council of the City of Riverside, California, that the following one-foot barrier strips are hereby accepted to public use for street purposes to be known as portions of Tyler Street, Jurupa Avenue and Idyllwild Lane:

Parcel 1

Lot F (1' barrier strip) and Lot G (1' barrier strip) of Tract No. 6537-1, as shown by map on file in Book 84 of Maps, at pages 79 through 81 inclusive thereof, Records of Riverside County, California;

Parcel 2

All that portion of Lot F (1' barrier strip) of Tract No. 6537-2, as shown by map on file in Book 86 of Maps, at Pages 49 through 50 inclusive thereof, Records of Riverside County, California, more particularly described as follows:

Beginning at the most northerly corner of Lot 45 of said Tract No. 6537-2;

THENCE North 30° 02' 16" East along the north-westerly line of said Lot F, a distance of 54.00 feet;

THENCE South 59° 57' 44" East along the north-easterly line of said Lot F, a distance of 1.00 foot;

THENCE South 30° 02' 16" West, a distance of 54.00 feet to a point in the northeasterly line of said Lot 45;

THENCE North 59° 57' 44" West along said north-easterly line, a distance of 1.00 foot to the point of beginning.

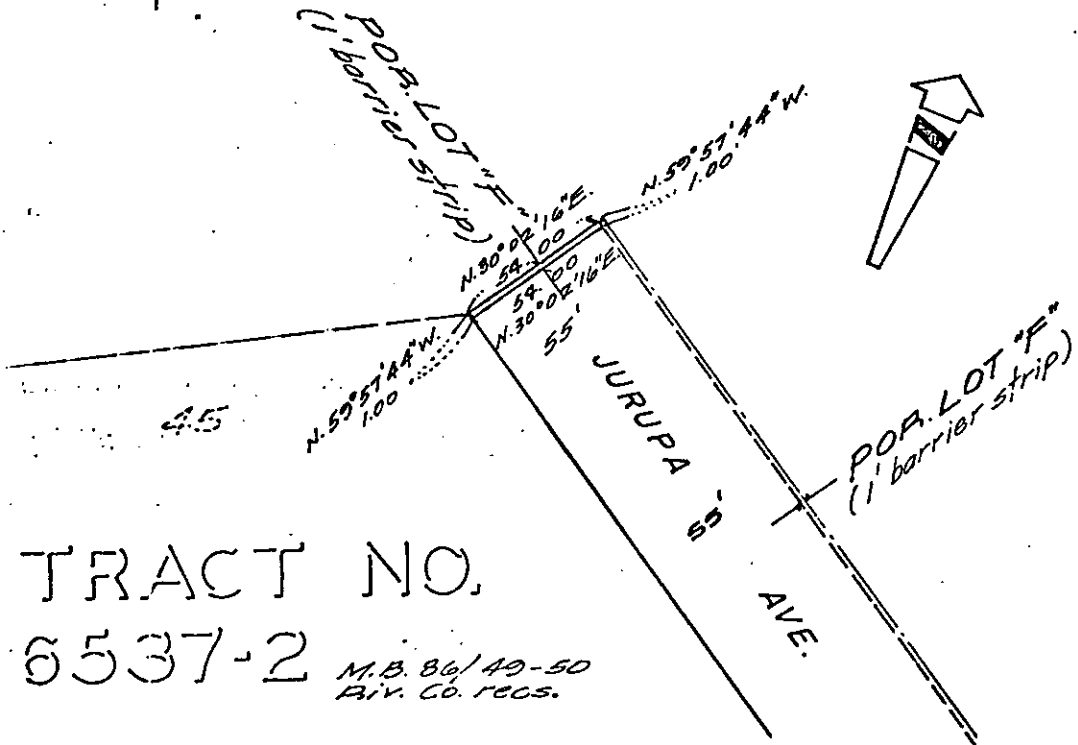
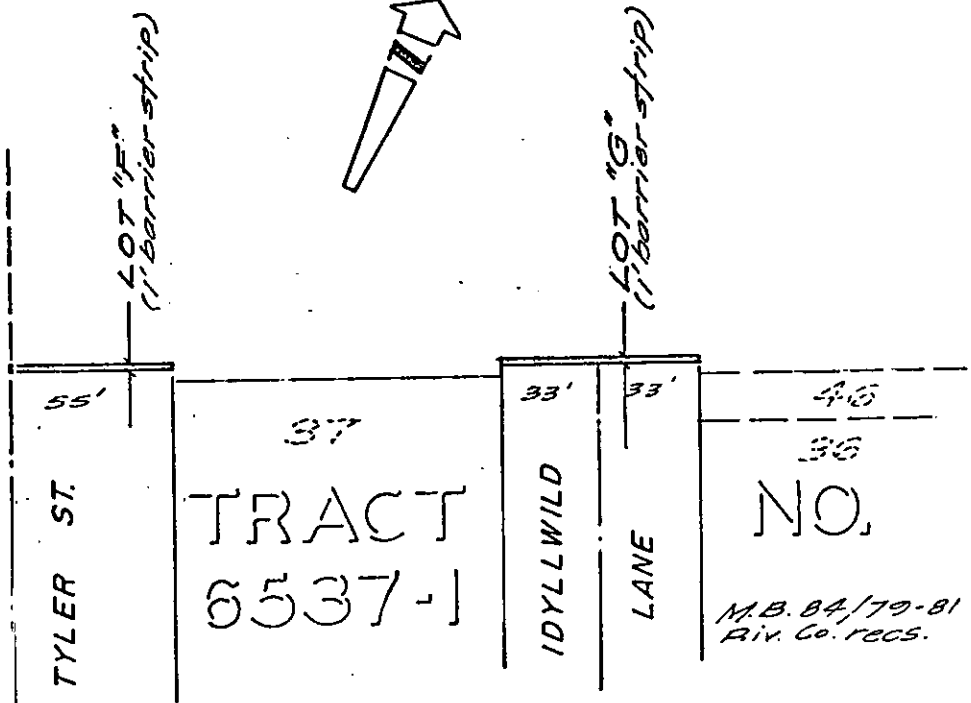
