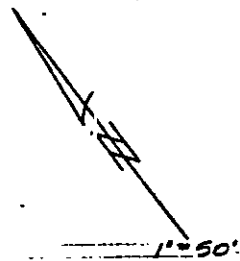

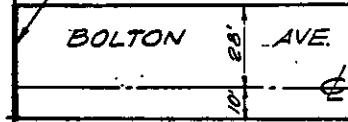

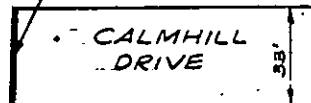


TRACT 8492
