
Parcel 1:

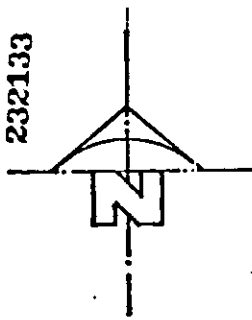

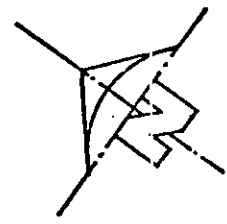
