RESOLUTION NO. 13322

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, DEDICATING AND ACCEPTING CERTAIN CITY-OWNED LAND FOR PUBLIC STREET PURPOSES

BE IT RESOLVED by the City Council of the City of Riverside, California, that the hereinafter described strip or parcel of land owned by the City of Riverside, being a portion of former Fire Station No. 8, be and is hereby dedicated by the City of Riverside and accepted for public use for street purposes to become and be known as a portion of Pierce Street. Said parcel or strip of land is located in the City of Riverside, County of Riverside, State of California, and is described as follows:

A strip of land 30.00 feet in width over a portion of Lot 7 in Block 57 of Tract No. 2 of LA SIERRA HEIGHTS, as shown by map on file in Book 7 of Maps, at Page 66 thereof, records of Riverside County, California, more particularly described as follows:

BEGINNING at the northwesterly corner of La Sierra Academy Tract No. 1, as shown by map on file in Book 13 of Maps, at Page 73 thereof, records of said Riverside County;

THENCE Southwesterly along the northwesterly line of said Lot 7, a distance of 100 feet;

THENCE Southeasterly and parallel with the southwesterly line of said La Sierra Academy Tract No. 1, a distance of 30.01 feet to a line which is parallel with and distant 30.00 feet southeasterly, as measured at right angle, from said northwesterly line of Lot 7;

THENCE Northeasterly along said parallel line 100 feet to said southwesterly line of La Sierra Academy Tract No. 1;

THENCE Northwesterly along said southwesterly line 30.01 feet to the point of beginning.

BE IT FURTHER RESOLVED that the City Clerk is authorized and directed to cause a certified copy of this resolution to be recorded in the office of the County Recorder of Riverside County, California.

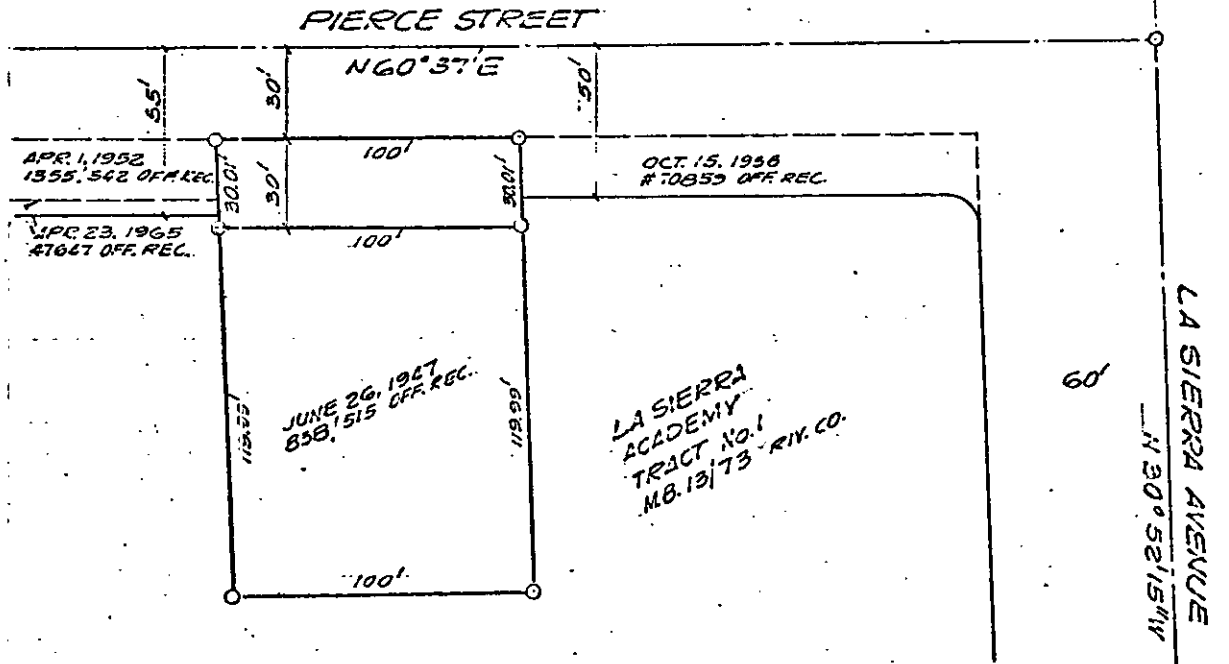
