OFFER OF DEDICATION

On this 9 day of APRIL, 1978

ROBERT J. SCOTT and BRENDA L. SCOTT, husband and wife, as joint tenants.

irrevocably offer for dedication to the CITY OF RIVERSIDE, a municipal corporation, pursuant to the provisions of California Government Code Section 7050, for public street and highway purposes, together with all rights to construct and maintain utilities, sewers, drains and other improvements consistent with the use as a public street and highway, that real property located in the City of Riverside, County of Riverside, State of California, and more particularly described as follows:

A strip of land 60.00 feet in width over a portion of Lot 7 in Block 74 of Tract No. 2 of La Sierra Heights, on file in Book 7 of Maps, at page 66 thereof, records of said Riverside County, the centerline of said strip of land more particularly described as follows:

BEGINNING at a point in the southwesterly line of said Lot, North 12° 05' West a distance of 117.00 feet from the most southerly corner of said Lot; said point being the beginning of a non-tangent curve with a radius of 241.00 feet and concaving southeasterly; the radial line of said curve at said beginning bears North 17° 01' 31" West;

THENCE Northeasterly along said curve an arc length of 2.31 feet, thru a central angle of 0° 32' 53" to the beginning of a reverse curve with a radius of 500.00 feet and concaving northwesterly;

THENCE Northeasterly along said reverse curve an arc length of 121.92 feet, thru a central angle of 13° 58' 14" to the beginning of a reverse curve with a radius of 500.00 feet and concaving southeasterly;

THENCE Northeasterly along last mentioned curve an arc length of 31.11 feet, thru a central angle of 3° 33' 53" to a point in the southwesterly line of that certain parcel of land conveyed to William Hines, et ux., by deed recorded October 18, 1957, as Instrument No. 75111 of Official Records of said Riverside County; said point being the end of this centerline description.

Area - 0.23 of an acre.

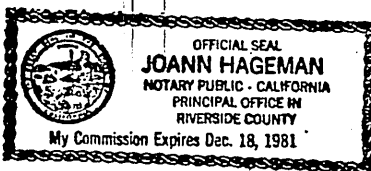

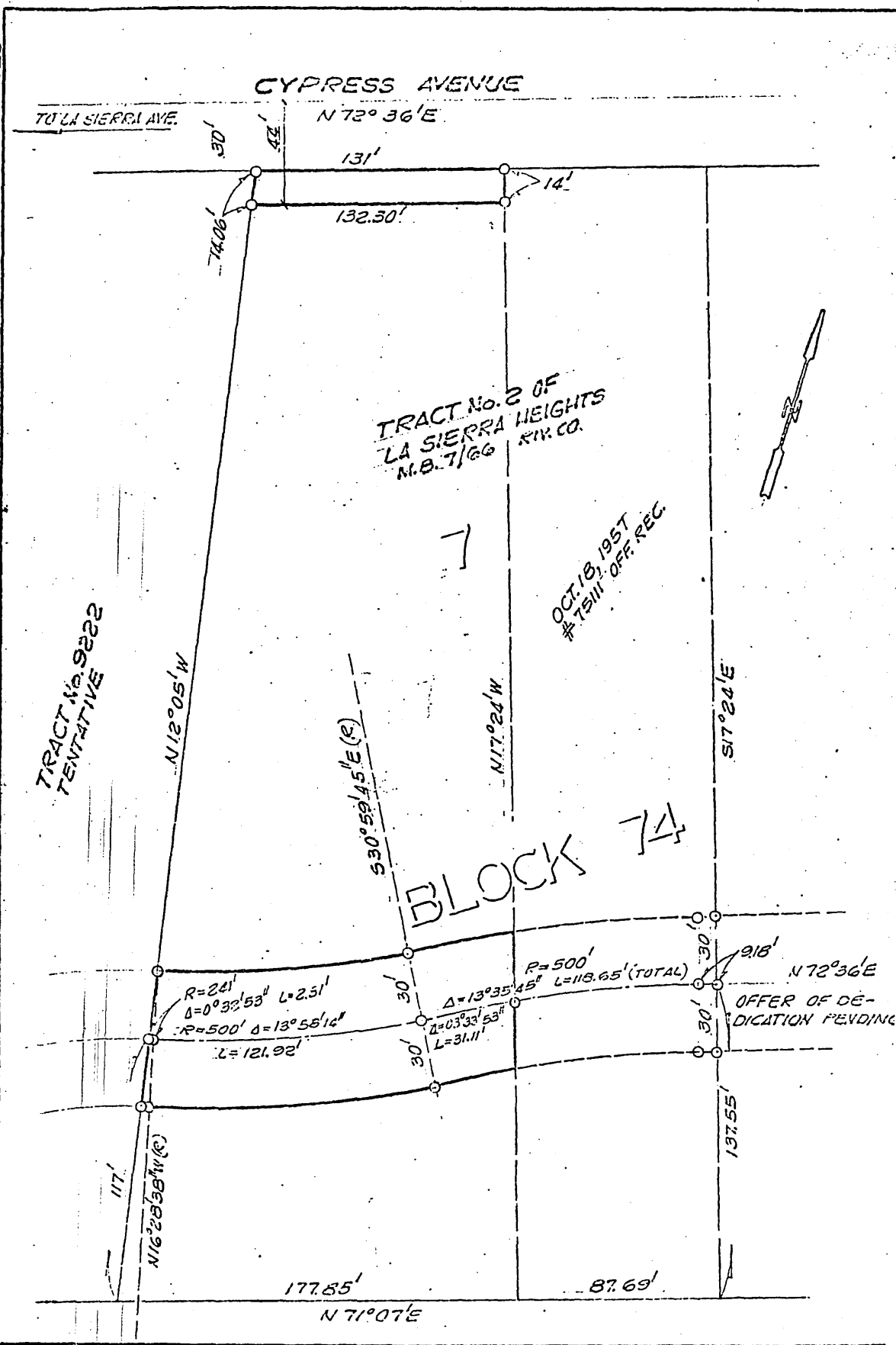
