TREE PLANTING EASEMENT

FOR VALUABLE CONSIDERATION, receipt of which is hereby acknowledged,
FACESETTER HOMES INC., a California corporation

as Grantor, grants to the CITY OF RIVERSIDE, a Municipal Corporation of
the State of California, as Grantee, a perpetual easement and right of way
for the tree planting, renewing and maintaining of trees of such types as
shall be designated by the City of Riverside in, under, upon, over and
along that certain real property situated in the City of Riverside, County
of Riverside, State of California, described as follows:

That portion of Lots 24 through 29 inclusive, of Tract 9297
as shown by map on file in Map Book 94, Page 8 thereof, Records
of Riverside County, California, described as follows:

BEGINNING at a point on the northerly line of Seneca Passage,
Lot D, of said Tract 9297, said point being the most easterly
terminus of a 100.00 foot radius curve in the southerly line of
said Lot 29;

THENCE North 52° 34' 04" East, a distance of 49.67 feet to the
beginning of a curve concave westerly and having a radius of
51.00 feet;

THENCE Easterly, Southerly, and Westerly along said curve
through a central angle of 210° 00' 00", an arc distance of 186.93
feet;

THENCE South 82° 34' 04" West, a distance of 49.67 feet; the
preceding three courses being along the northerly, easterly, and
southerly line of said Seneca Passage;

THENCE North 88° 40' 55" East, a distance of 43.95 feet to the
beginning of a curve concave westerly and having a radius of 56.00
feet;

THENCE Easterly, Northerly, and Westerly along said curve, through
a central angle of 222° 13' 42", an arc distance of 217.20 feet;

THENCE South 46° 27' 13" West, a distance of 43.95 feet to the point
of beginning.

Said tree planting easement is to be used for all purposes proper and convenient in the planting, renewing and maintenance of trees, including the rights of ingress and egress, the temporary deposit of tools, equipment, machinery, vehicles, materials and supplies used in the performance of said work, and for similar and related purposes by the City of Riverside, its officers, employees, agents or contractors.

Provided, however, that the Grantor(s) reserve(s) the right of use and enjoy the land over which said easement and right of way is granted, for any purpose and in any manner which does not interfere with or impair the right of the Grantee to use said easement and right of way.
