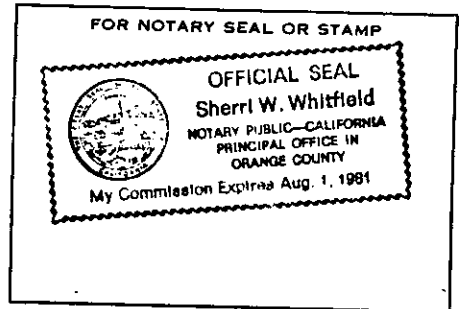

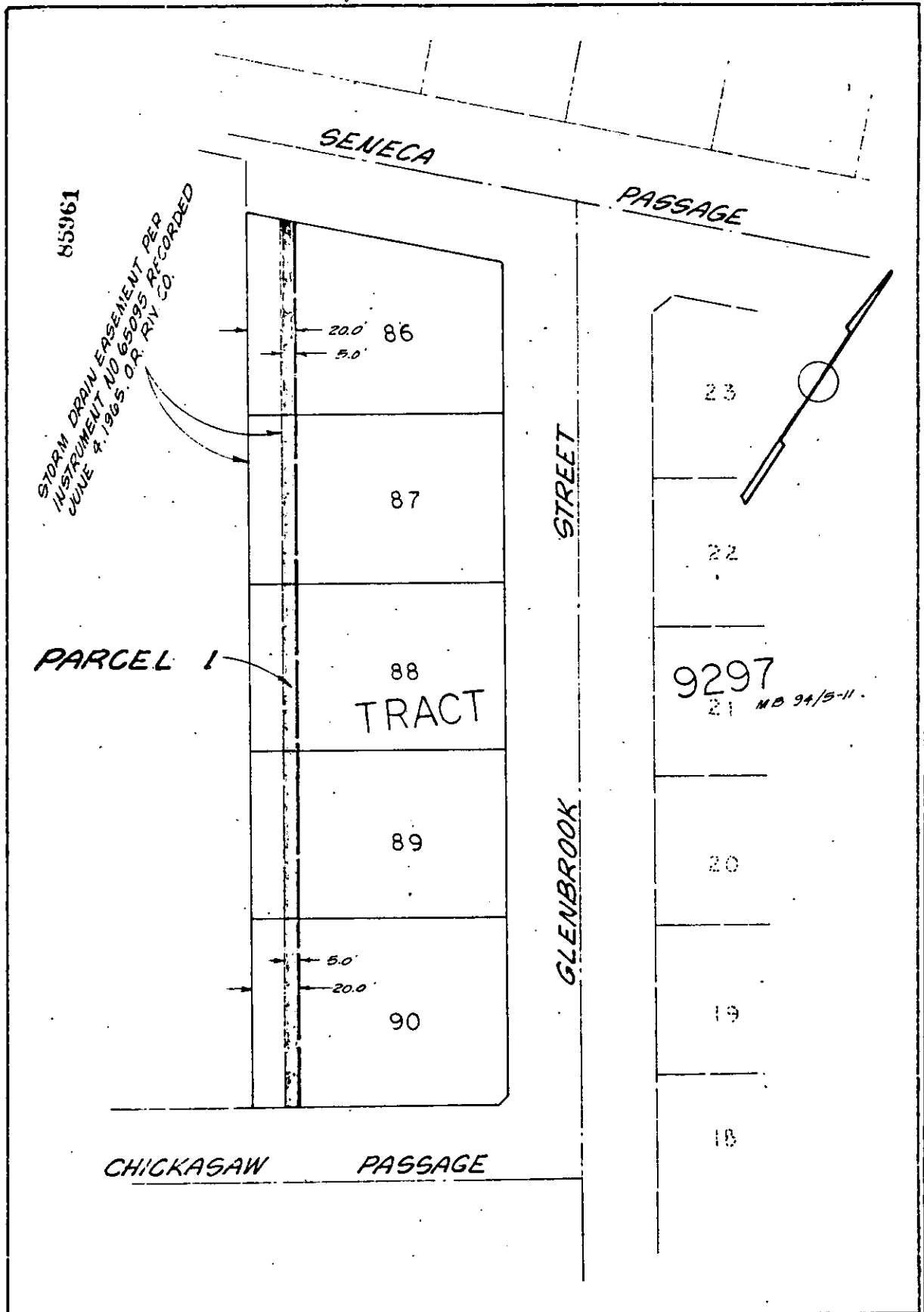
CONSENT TO RECORDATION
