A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, CHANGING THE NAME OF A PORTION OF FAIRVIEW AVENUE TO SUNSET DRIVE.

BE IT RESOLVED by the City Council of the City of Riverside, California, pursuant to the recommendations of the Planning Commission of the City of Riverside, that the name of a portion of Fairview Avenue, situated at the end of Sunset Drive, easterly of the Gage Canal, and described as follows:

All that portion of Fairview Avenue (a street of variable width) as shown by Record of Survey on file in Book 28 of Records of Survey, at Page 55 thereof, records of Riverside County, California, lying southwesterly of the southwesterly terminus of that portion of Fairview Avenue as vacated by the City Council of the City of Riverside, Resolution No. 9912, recorded February 27, 1964, as Instrument No. 24798 of Official Records of said Riverside County, and lying northeasterly of the westerly prolongation of the southerly line bearing North 78° 01' 30" West of Parcel 2 of said Record of Survey,

be changed to SUNSET DRIVE.
