a street created by Parcel Map 9352 and situated northwesterly  
of the terminus of Merida Place, westerly of Butler Drive,  
described as follows:

All that portion of Koinonia Place lying  
southerly of the northerly boundary of Parcel Map  
No. 9352, on file in Book 54 of Parcel Maps, at  
Page 5 thereof, records of Riverside County,  
California, and lying northerly of the following  
described line:

Beginning at the southeasterly corner of Parcel 1  
of said Parcel Map No. 9352;  
Thence North 47° 35' 14" East, 74.68 feet to  
the southwesterly line of Parcel 2 of said Parcel  
Map No. 9352 and to the end of this line description,

be changed to ALTA MIRA WAY.

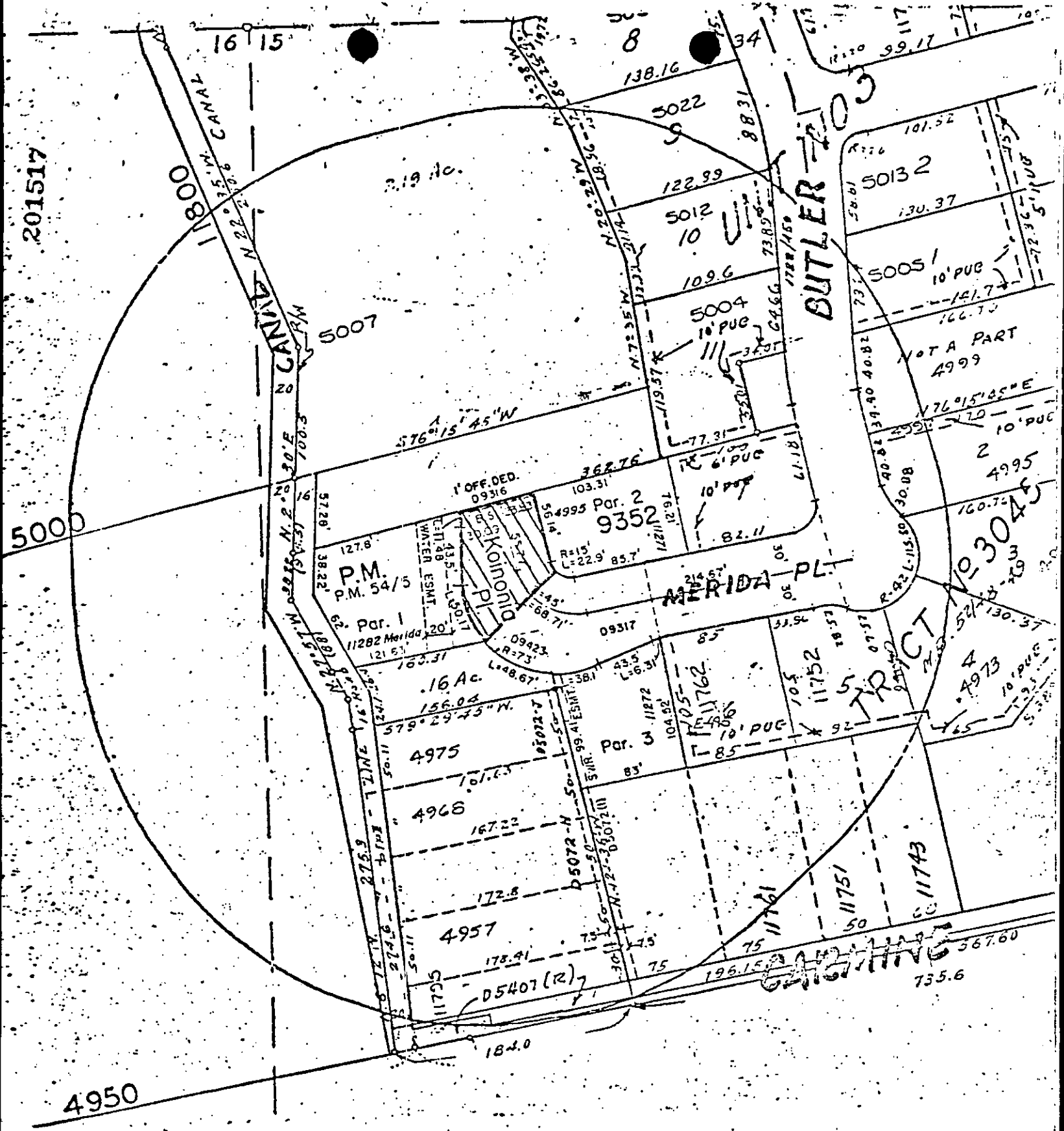

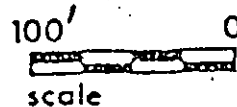
