All that portion of California Avenue lying north of the east prolongation of the south line of Block 20 of Twogood and Herrick's Subdivision, as shown by map on file in Book 7 of Maps, at Page 29 thereof, Records of San Bernardino County, California, and lying south of the east prolongation of the north line of Block 84 of East Riverside, as shown by Map on file in Book 7 of Maps, at Page 33 thereof, Records of said San Bernardino County,

be changed to NORTHGATE STREET.

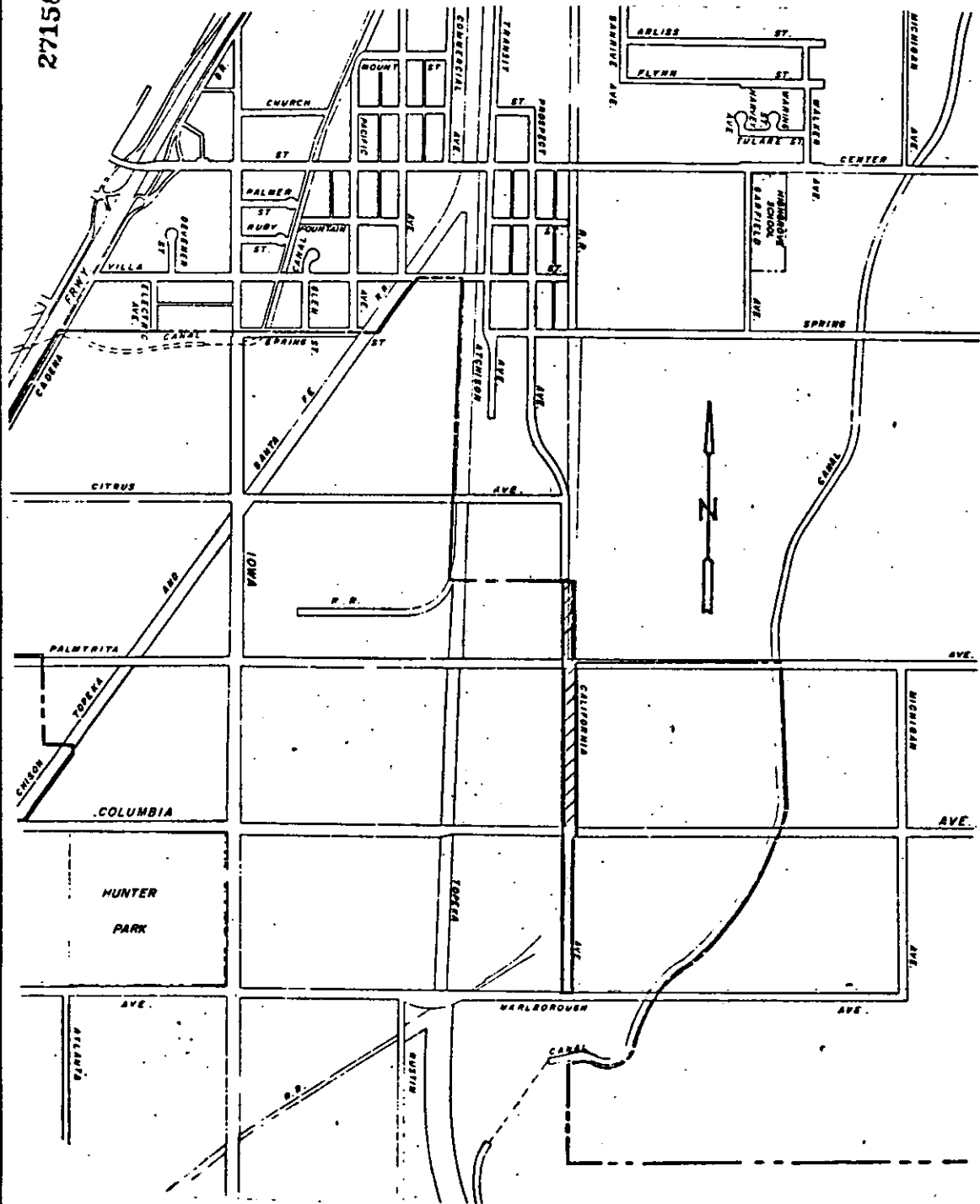

6 public hearing after due notice has been held upon a resolution of intention to  
7 change the name of CALIFORNIA AVENUE, in the Highgrove area, Fifth Supervisorial  
8 District, and all persons having had an opportunity to be heard, now, therefore:

9 BE IT RESOLVED by the Board of Supervisors of the County of Riverside,  
10 State of California, in regular session assembled on September 11, 1979, that the  
11 name of CALIFORNIA AVENUE, lying westerly of The Southern Pacific Railway and  
12 extending from the southerly line of Citrus Street southerly to the southerly  
13 line of Lot 71 as shown on Record of Survey, Book 4D, Page 73, Riverside County  
14 records, in the Highgrove area, Fifth Supervisorial District, is changed to
