A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, CHANGING THE NAME OF A PORTION OF LIBERTY STREET TO DENNEY PLACE.

BE IT RESOLVED by the City Council of the City of Riverside, California, pursuant to the recommendation of the Planning Commission of the City of Riverside, that the name of the portion of Liberty Street between Fremont and Griffith Streets, and described as follows:

All that portion of Liberty Street as shown by Tract No. 3 of the Riverview Addition to the City of Riverside, on file in Book 7 of Maps, at page 5 thereof, records of Riverside County, California, lying east of a line which is parallel with and distant 33 feet east, as measured at right angle, from the centerline of Griffith Street and lying west of a line which is parallel with and distant 33 feet west, as measured at right angle, from the centerline of Fremont Street,

be changed to DENNEY PLACE.
