A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, ACCEPTING CERTAIN ONE-FOOT BARRIER STRIPS WITHIN TRACT NO. 6909 AND TRACT NO. 6756-4 (WHICH BARRIER STRIPS ADJOIN TRACT NO. 6756) FOR STREET PURPOSES TO BE KNOWN AS PAINE DRIVE AND CAPITOL DRIVE.

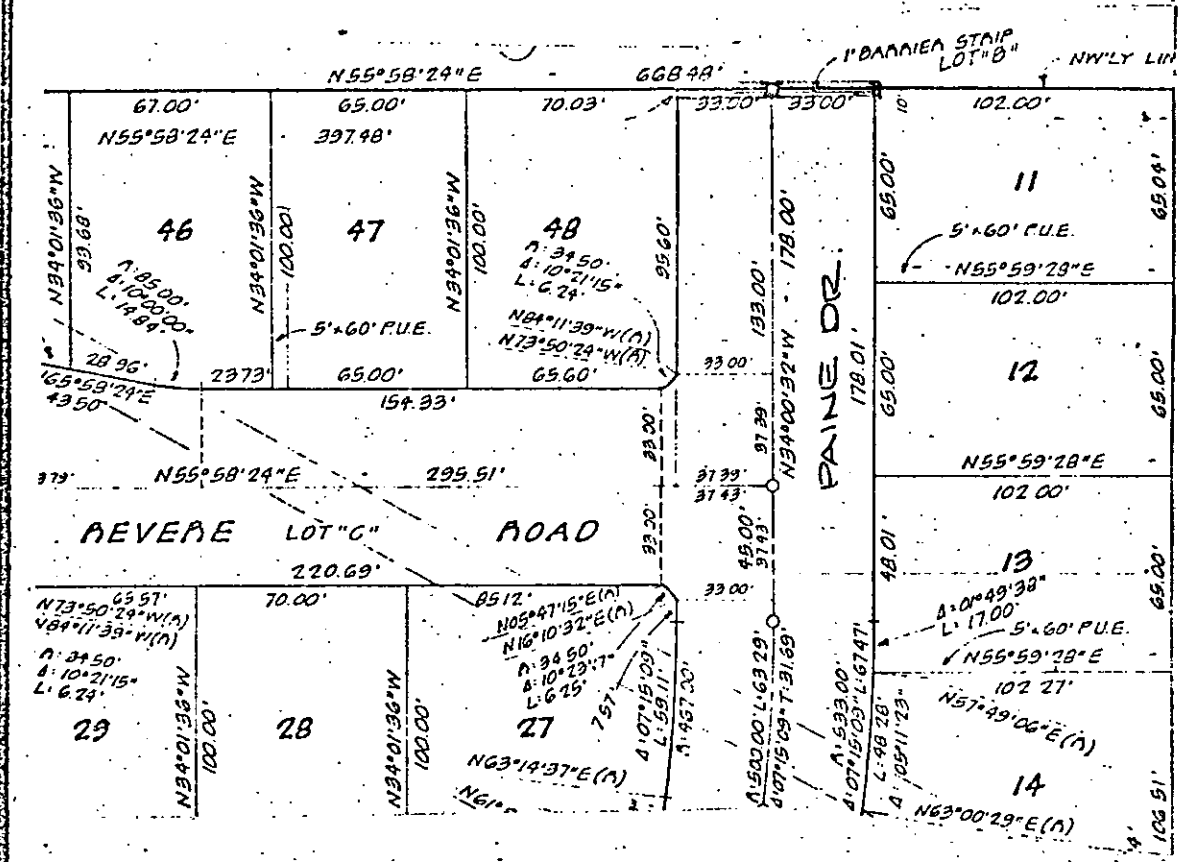

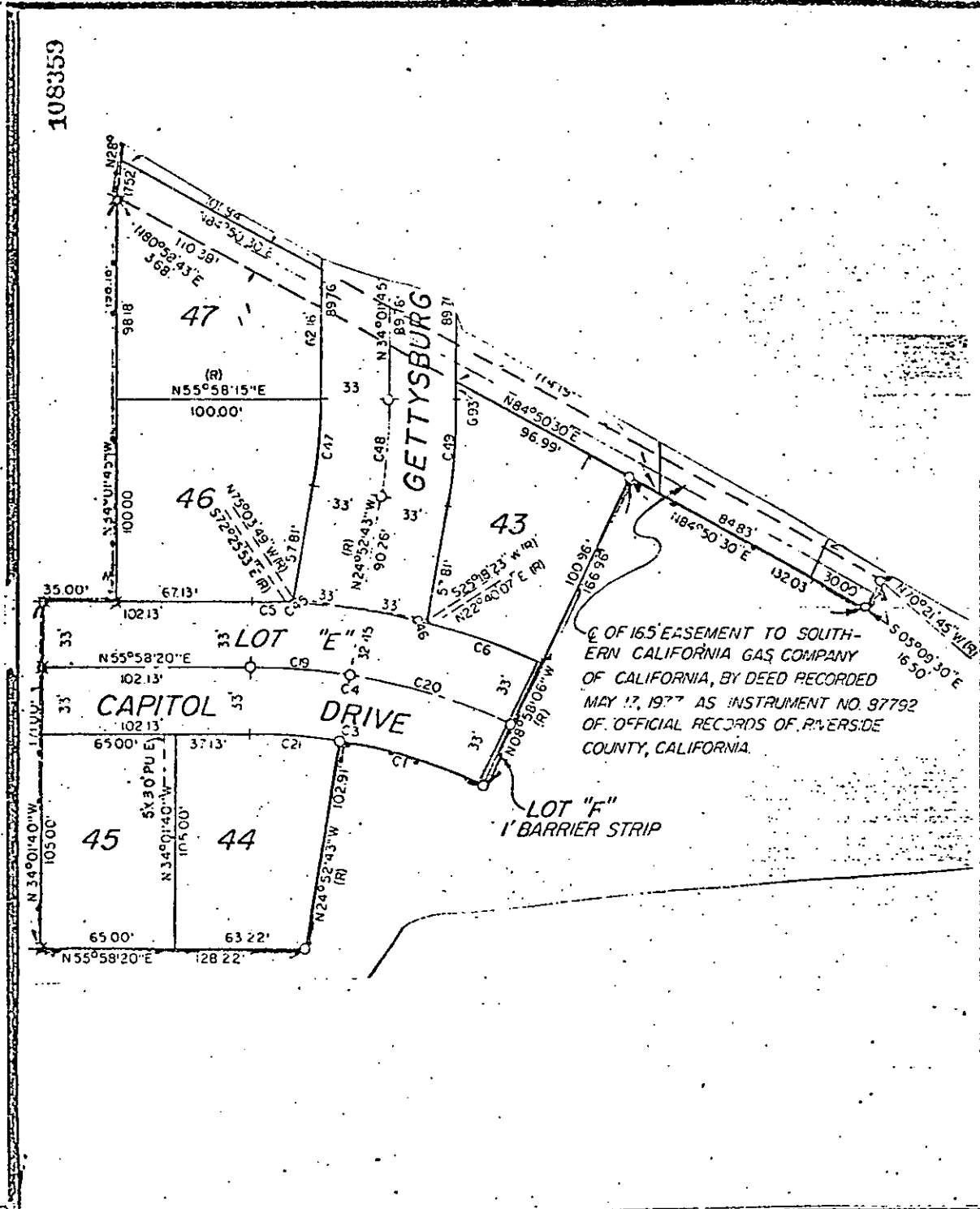
