PORTION OF VALLEY VIEW FARMS PER M.B. 11 / 58, RECORDS OF RIV. CO., CA.

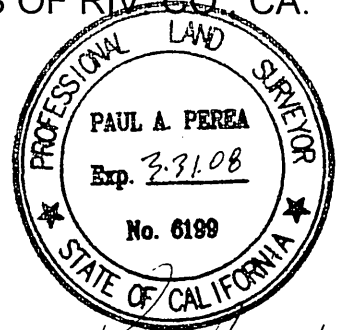
