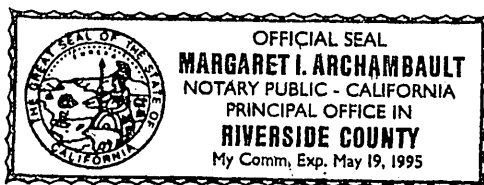

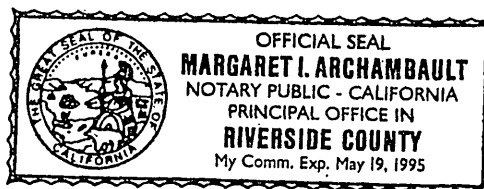

Thence South 16° 54' 35" East, a distance of 369.02 feet to the true point of beginning.
