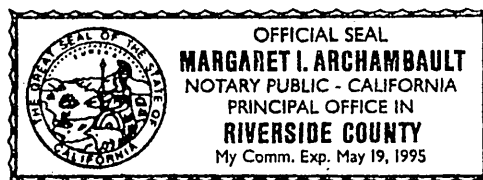

Thence S.88°39'50"E., along the North line of said Lot "B," also being the North line of said Parcel 2, a distance of 101.59 feet to the Northeast corner of said Parcel 2, also being the Northwest corner of Parcel 1 of Certificate of Compliance recorded December 2, 1986 as Instrument No. 305785, Official Records of Riverside County, California, said corner being the point of beginning of the parcel of land to be described;

The following six (6) courses are along the Westerly and Southerly lines of said Parcel 1;

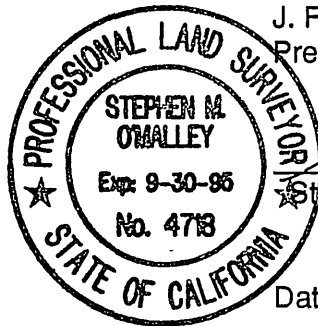
