

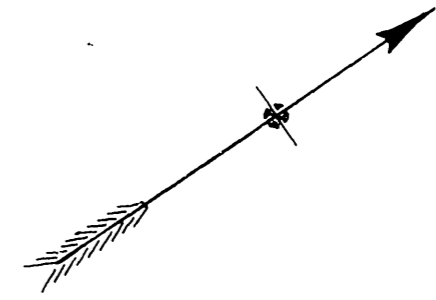
Map of VISTA HERMOSA TRACT.


