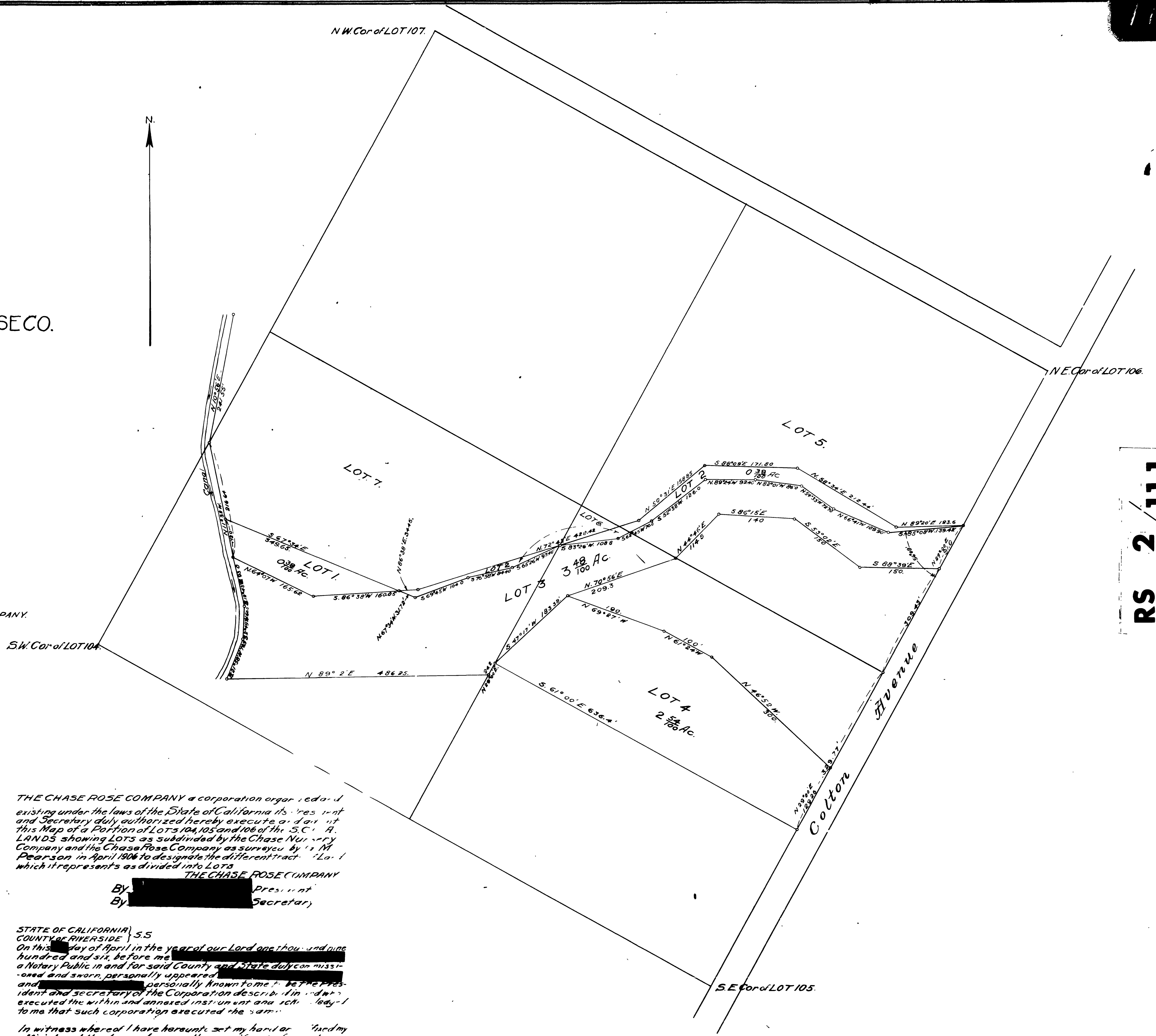
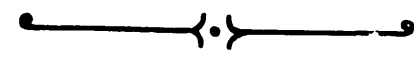


MAP
