LETT'S RESUBDIVISION OF A PORTION OF LOT 22 OF THE LANDS OF THE S.C.C.A.

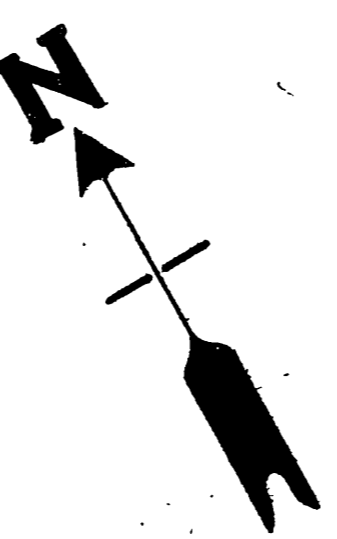
AND OF A PORTION OF LOT 29

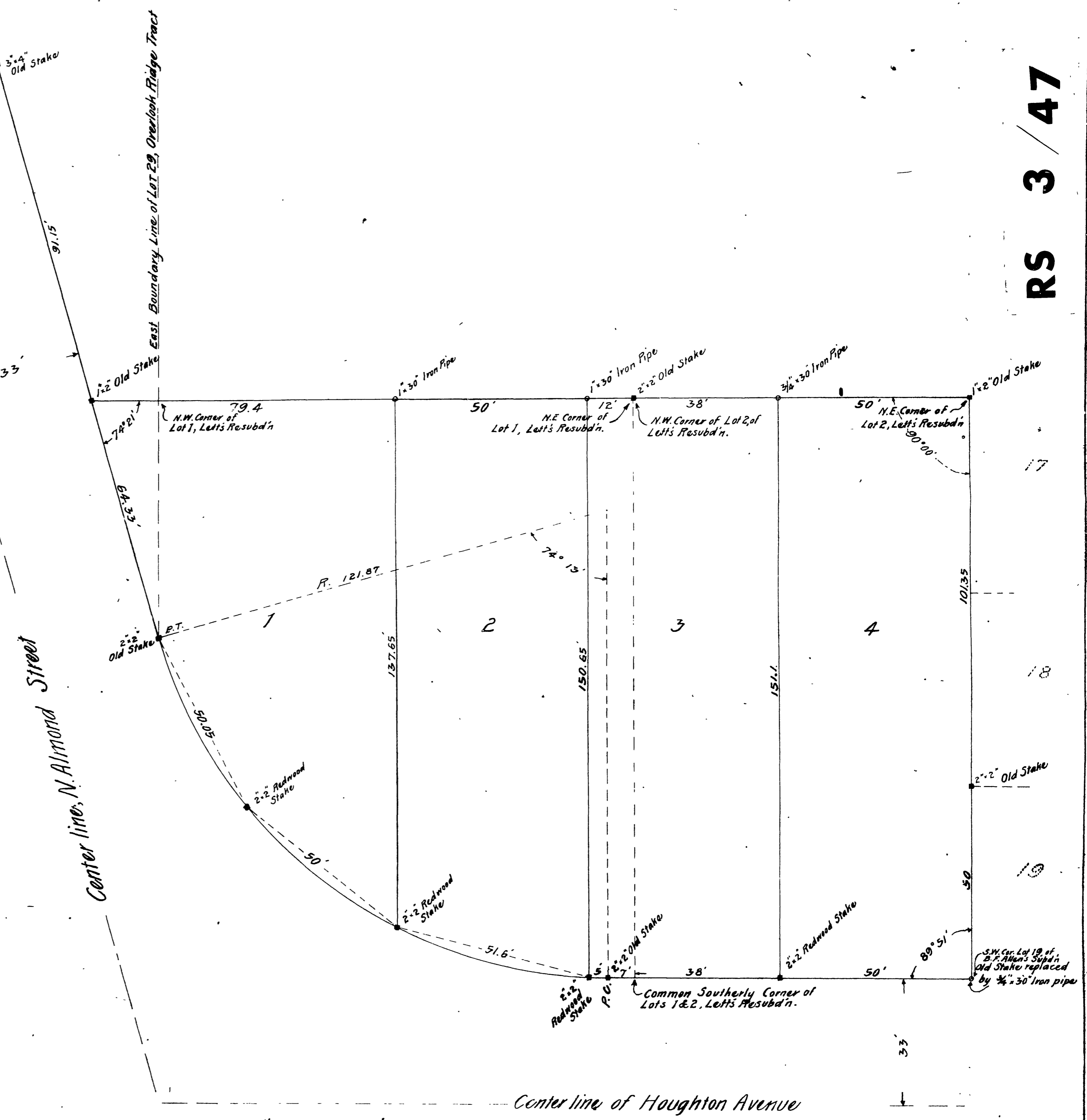
