

- GENERAL NOTES**
1. The private engineer signing these plans is responsible for the accuracy and acceptability of the work hereon. In the event of discrepancies arising during construction, the private engineer shall be responsible for determining an acceptable solution and revising the plans for approval by the City.
 2. Construction shall be in accordance with Standard Specifications for Public Works Construction, 1976 Edition, and City of Riverside Standard Drawings.
 3. It shall be the responsibility of the Contractor to clear the right of way in accordance with the provisions of law as it affects each utility including irrigation lines and appurtenances and at no cost to the City.
 4. Pipe shall be bedded per Case 1, Standard Drawing No 432, unless otherwise specified on plans.
 5. Location of Wyes and Laterals to be determined at the direction of the owner.
 6. All stubs and laterals to be constructed in accordance with standard Drawing 522. Stubs to be plugged and capped.
 7. The sewer contractor shall adjust manholes to final grade after paving is completed.
 8. Laterals are to be 4' and extended to property line.
 9. Encase Sewer 4.5' each side of proposed water main crossing per Public Utilities Drawing C.W.D 023, Type B.
 10. Plugs shall be installed and will remain in place where the new sewer connects with the existing sewer until such time as the new sewer is accepted by the City.
 11. Contractor is to verify existing sewer elevation prior to construction.

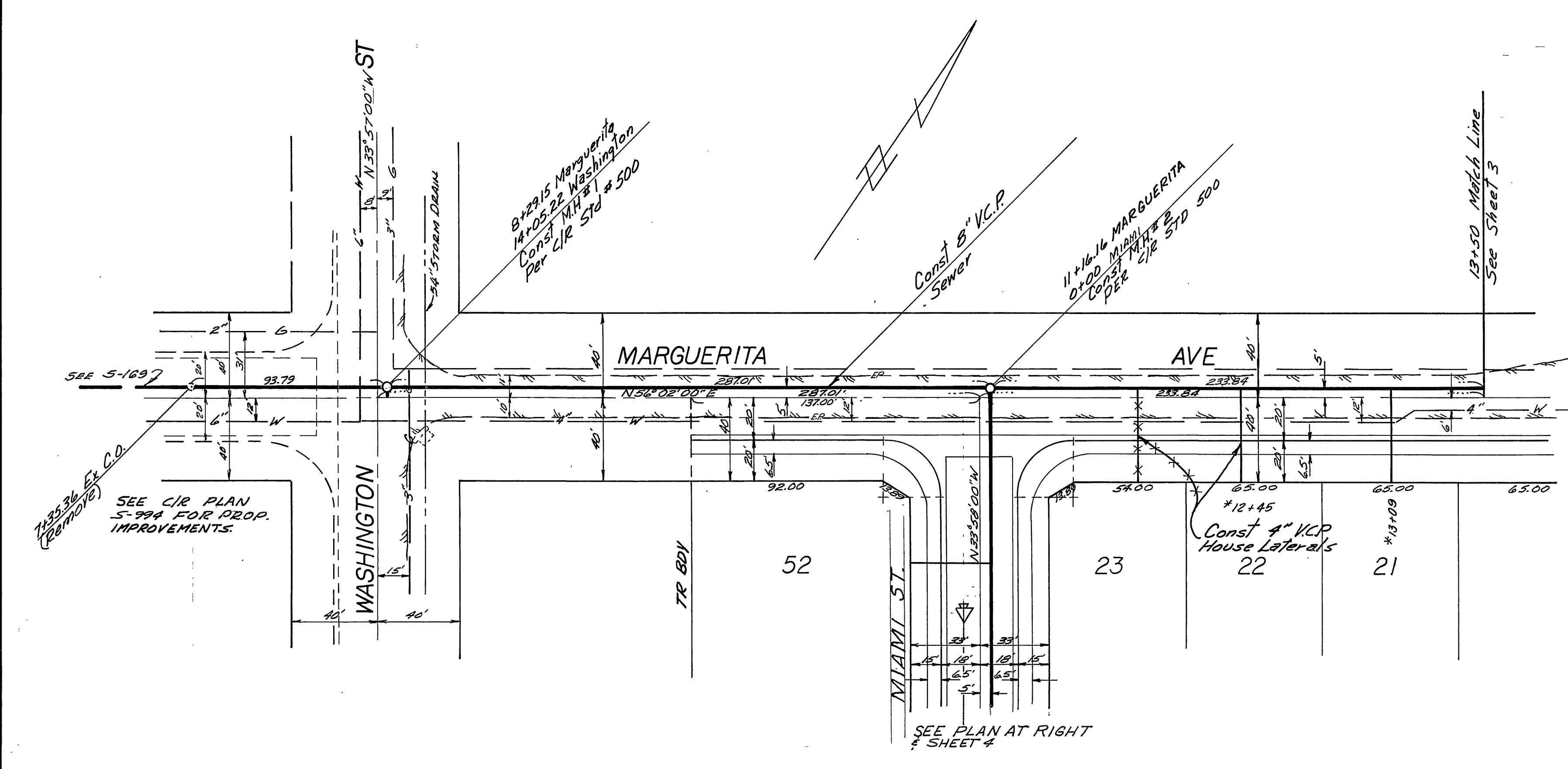
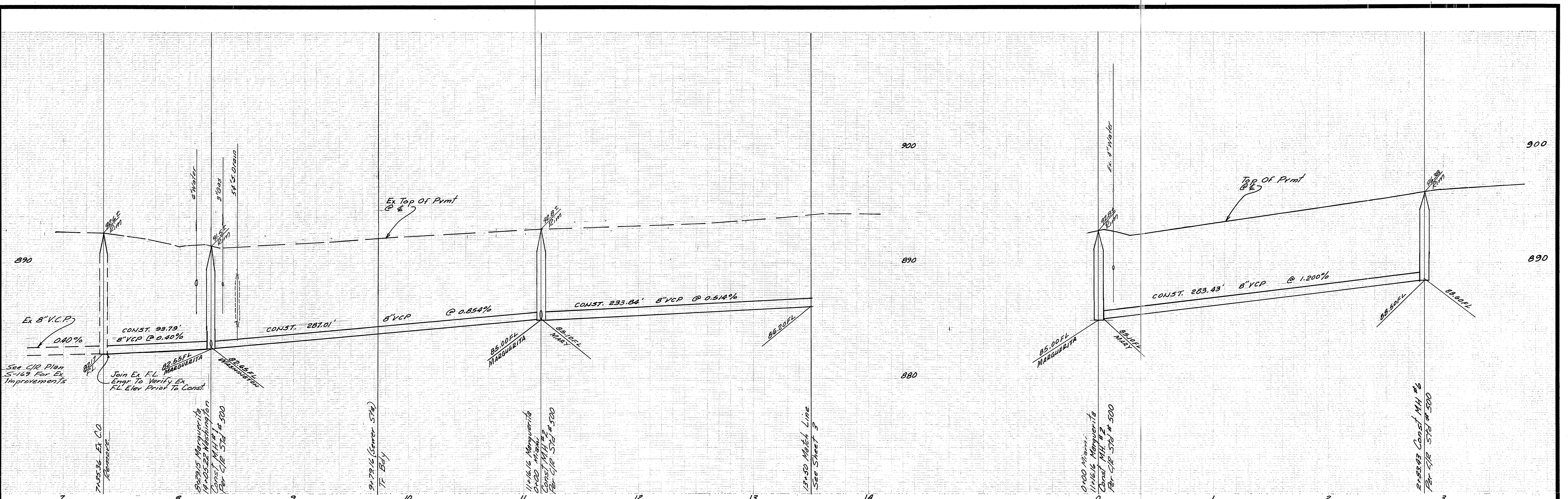
NOTICE TO CONTRACTOR

The Contractor is required to take due precautionary measures to protect the utility lines shown and any other lines not of record or not shown on these plans.

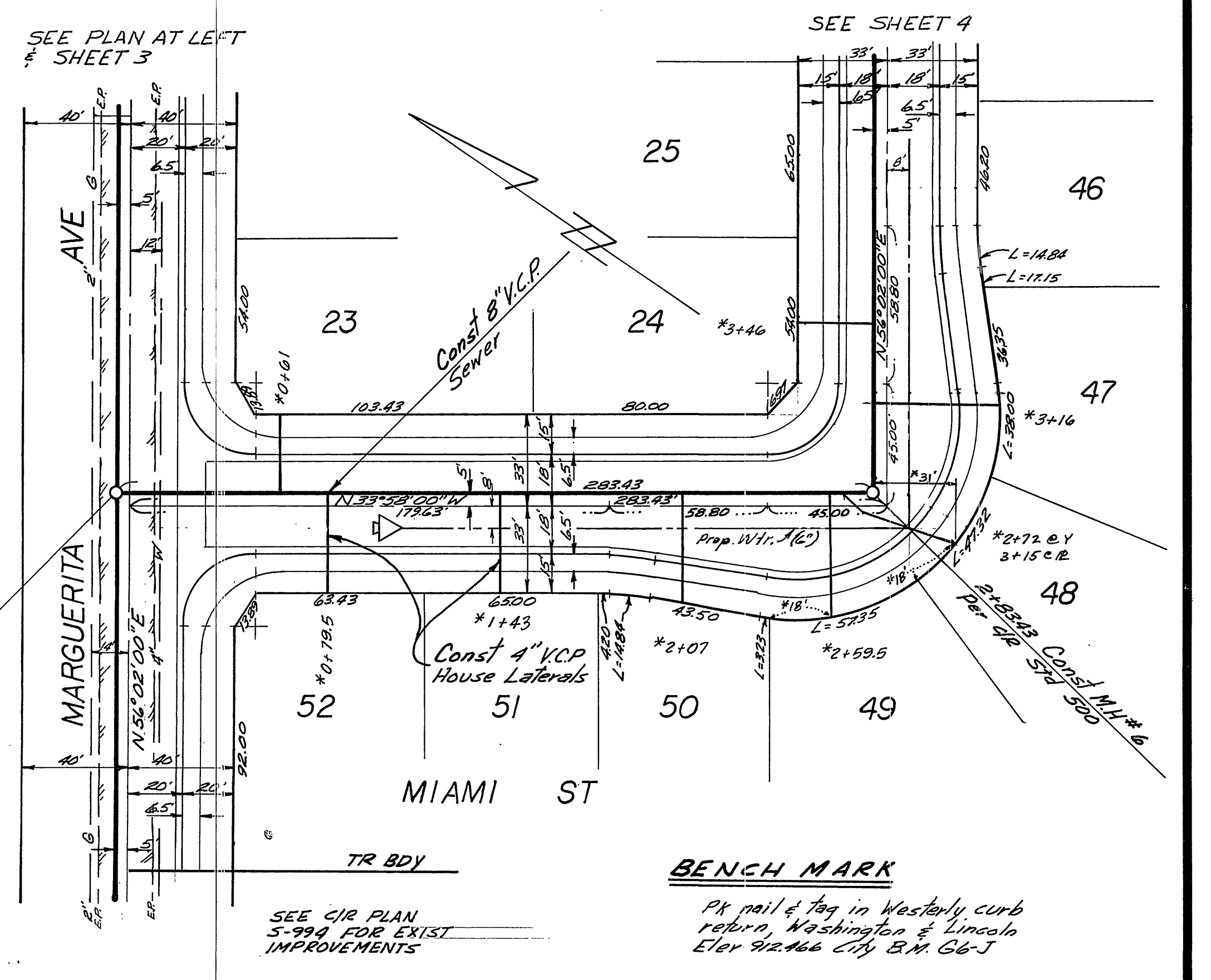

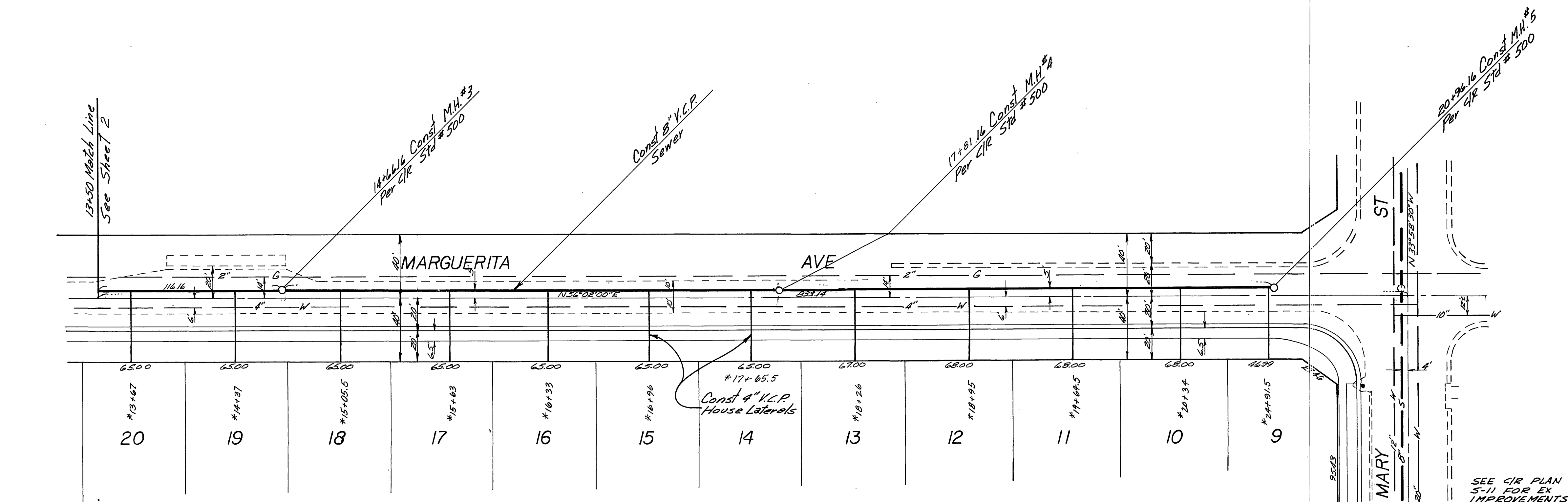
