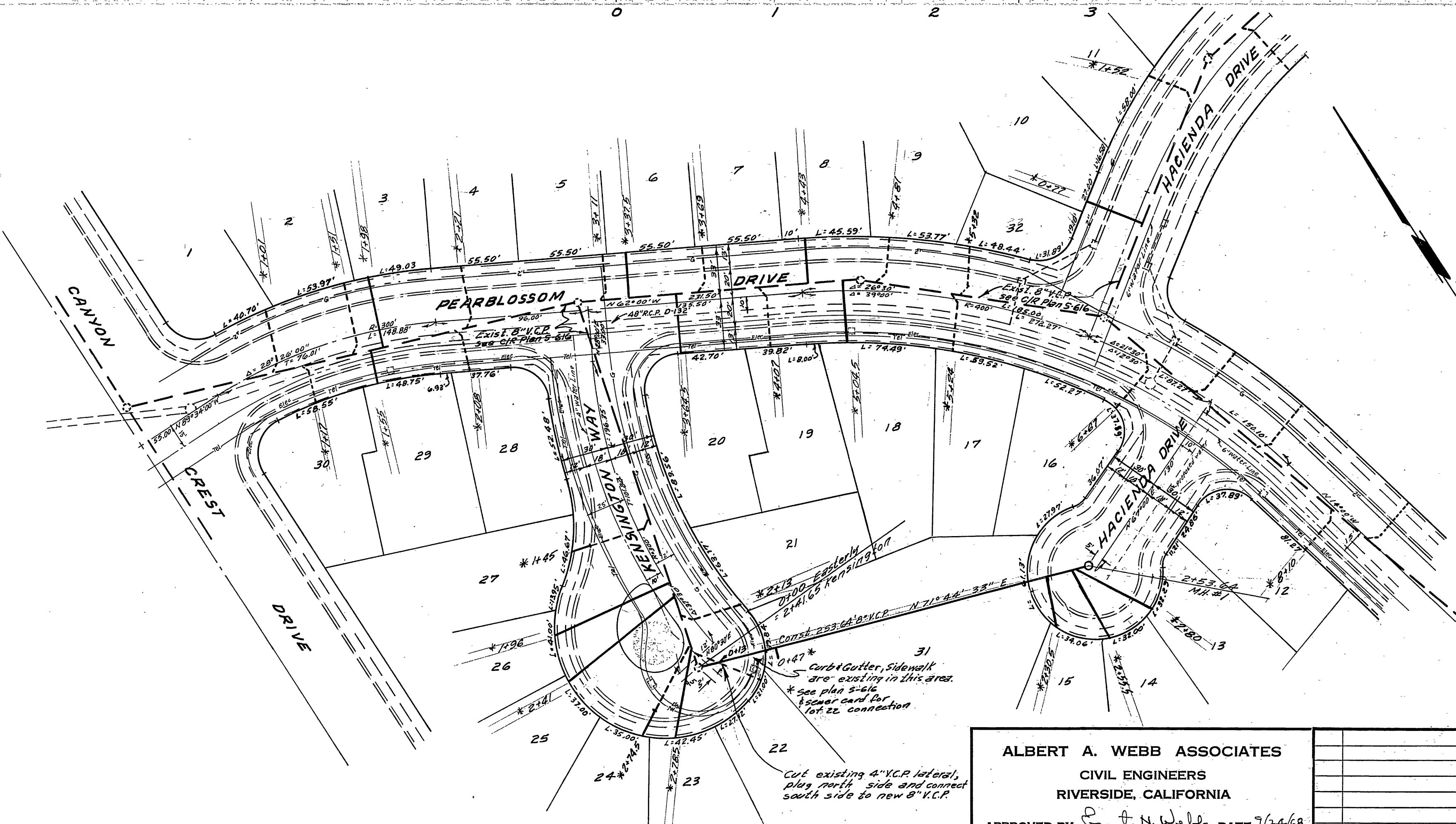
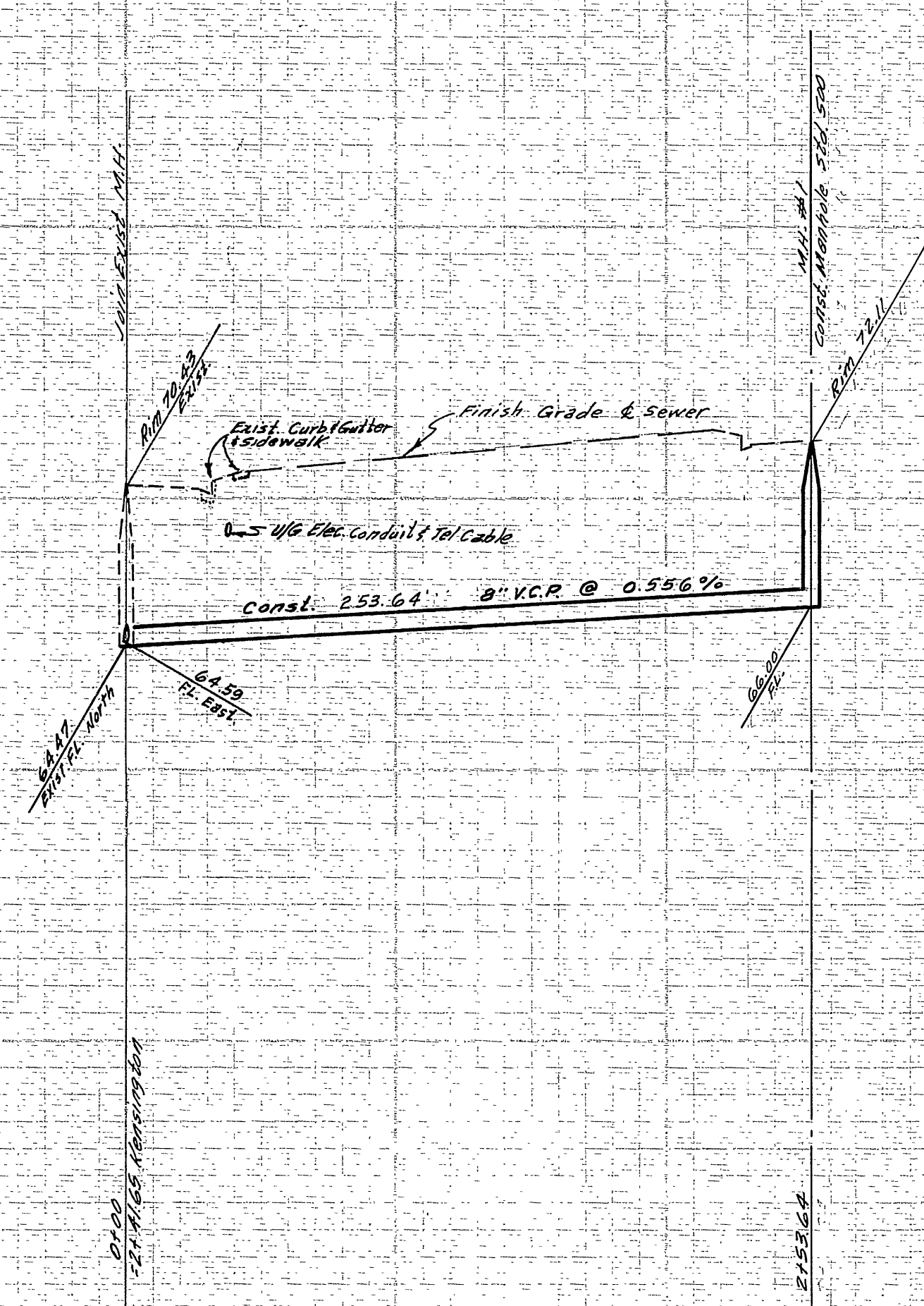

- GENERAL NOTES
1. This shall be the responsibility of the contractor to obtain the right of way in accordance with the provisions of the law as it affects each utility including the location and appearance and at no cost to the City.
 2. Joints shall be in accordance with ASTM Specifications C-425-44 Type I or II, or to ASTM Specifications C-534-44 (Hand Seal) with certain exceptions or modifications on file with the City Engineer.
 3. Pipe shall be bedded per Case J, Standard Drawing No. 362, unless otherwise specified on plan.
 4. Location of wyes and laterals to be determined at the direction of the owner.
 5. All stubs and laterals to be constructed in accordance with Standard Drawing No. 362. Stubs shall be capped and sealed.
 6. Manhole frames and covers to be set to proposed elevations on plan.
 7. Laterals are to be 4" and extended to the curb.
 8. Prior to construction of sewer, contractor shall locate existing sewer and contact Engineer for construction of sewer.
