
TYPICAL SECTION OF CURB LINE SIDEWALK



GENERAL CONSTRUCTION NOTES


- EXISTING UTILITIES, SHOWN ON THIS PLAN, ARE PLOTTED FROM UTILITY RECORDS. THE CONTRACTOR IS REQUIRED TO TAKE DUE PRECAUTIONARY MEASURES TO LOCATE AND PROTECT ALL UTILITIES WHETHER OR NOT SHOWN ON THIS PLAN. THE UTILITY IS NOT EXPECTED TO CONFLICT WITH THE PROPOSED IMPROVEMENTS.
- 2 PRIME CONTRACTORS BIDDING THIS WORK SHALL HAVE A CLASS A OR C-8 LICENSE.
- TO CONSTRUCTION.
- TREES AND SHRUBS, AFFECTED BY THE PROPOSED SIDEWALK CONSTRUCTION, SHALL BE TRIMMED TO AT LEAST 8' VERTICALLY ABOVE THE SIDEWALK SURFACE AND TO AT LEAST 3' LATERALLY OF THE SIDEWALK, WHERE RIGHT—OF—WAY PERMITS.
- MAIL BOXES, INTERFERING WITH PROPOSED SIDEWALK CONSTRUCTION, SHALL BE TEMPORARILY RELOCATED TO ENABLE PROPERTY OWNERS TO RECEIVE THEIR MAIL AND BE REINSTALLED
- WATER METERS, GAS METERS AND ALL STREET PULL BOXES AFFECTED BY CONSTRUCTION, SHALL BE ADJUSTED TO THE PROPOSED SIDEWALK GRADE.
- 7 EXISTING SPRINKLERS AND IRRIGATION LINES, AFFECTED BY THE CONSTRUCTION OF THE PROPOSED SIDEWALK, SHALL BE RELOCATED TO THE BACK OF THE SIDEWALK OR MODIFIED TO COVER EXISTING IRRIGATION AREA EXCEPT THE NEW PAVED AREA.


- NUMBERS, ABOVE 100 IN A HEXAGON ON THE PLAN, REFER TO THE RESPECTIVE STANDARD DRAWING AND SHALL BE CONSTRUCTED ACCORDINGLY, UNLESS MODIFICATIONS ARE NOTED ON THE PLAN OR COVER SHEET. ANY NUMBER SHOWN BELOW THE STANDARD DRAWING NUMBER INDICATES THE SPECIFIC ALTERNATE TO BE CONSTRUCTED.
- $\frac{\langle R \rangle}{I}$ REMOVE EXISTING TREE. CLASS I: 6" TO 18", CLASS II: 18" TO 36", CLASS III: OVER 36".
- REL RELOCATE CHAINLINK FENCE OR WROUGHT IRON FENCE TO 0.5' OUTSIDE R/W. (NOTE: REUSE EXISTING FENCE FABRIC AND USE NEW IN KIND POSTS)
- CONSTRUCT WHEELCHAIR RAMP PER STD. DWG. 304 OR MODIFIED WHEELCHAIR RAMP SHOWN ON THIS PLAN.

PROJECT LOCATION MAP




