


BENCH MARK: Elev. 771.64
Nail in RR #12663J North side of Jurupa 300' West of Wilderness

GENERAL NOTES:

1. It shall be the responsibility of the contractor to clear the right of way in accordance with the provisions of law as it affects each utility including irrigation lines and appurtenances and at no cost to the City.
2. Construction shall be in accordance with the City of Riverside, Department of Public Works, Specifications No. 461 and Standard Drawings.
3. Prime coat, seal coat, and paint binder are required.
4. Grading will require a permit under Ordinance 3093 for a cut or fill exceeding 100 cubic yards, or a fill over one foot in depth.
5. Trim edge of existing pavement, when new paving joins existing pavement to a clean, straight line. Construct match-up paving as shown and overlay paving as directed in the field to produce a smooth crown section.
6. **NOTICE TO CONTRACTOR:** The existence and location of any underground utility pipes or structures shown on these plans are obtained by a search of the available records. To the best of our knowledge, there are no existing utilities except as shown on these plans. The Contractor is required to take due precautionary measures to protect the utility lines shown and any other lines not of record or not shown on these plans.
7. Contractor shall contact City Engineer regarding work shown as "By City".
8. Disposition of street excavation shall be as directed by owner and in accordance with City of Riverside Ordinance 3093 "Grading Ordinance".



STREET PLAN & PROFILE





