FAIRMOUNT HEIGHTS,

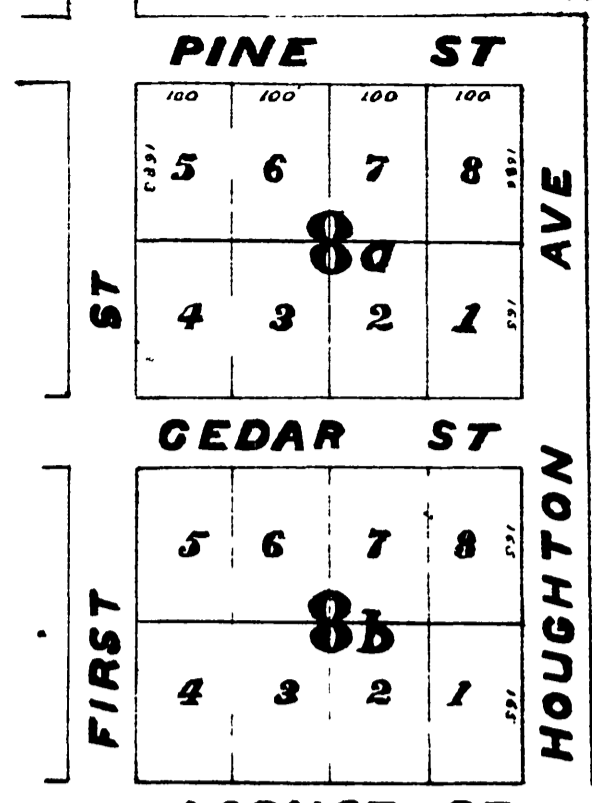
BEING A SUB DIVISION OF "BLOCK 8" AND A PORTION
