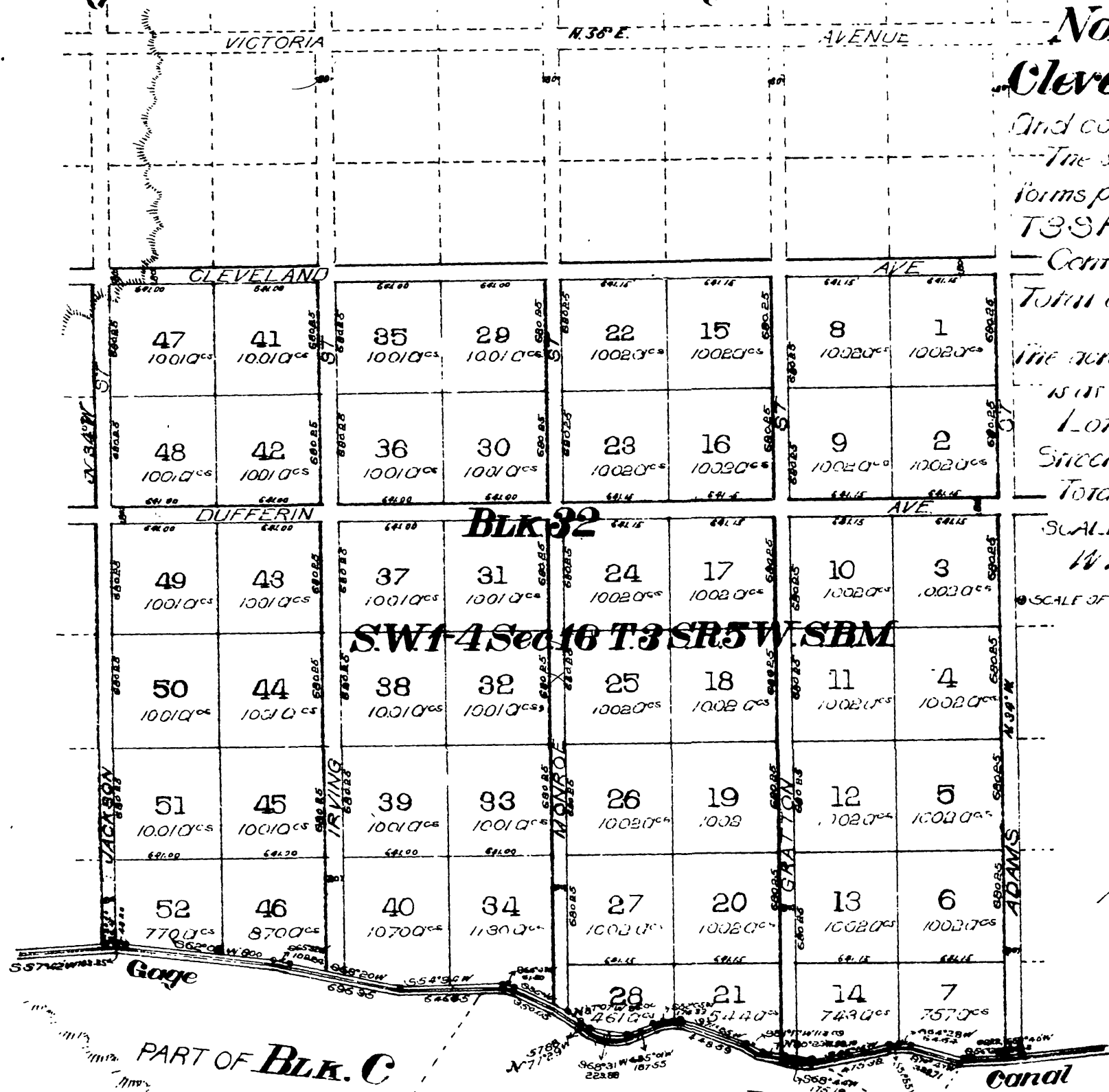


### Resubdivision
