

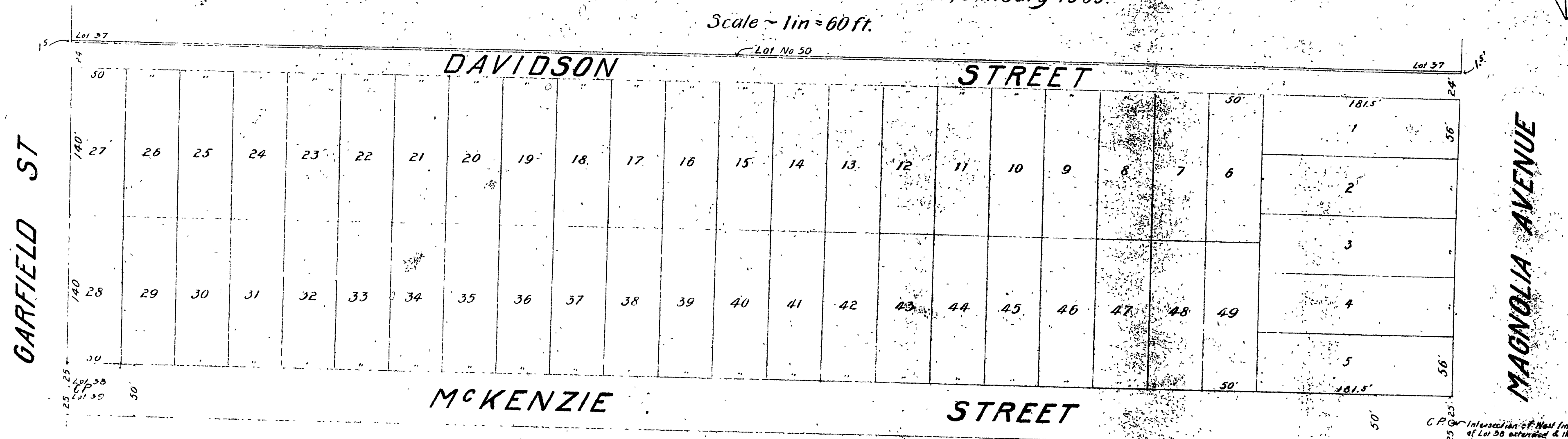
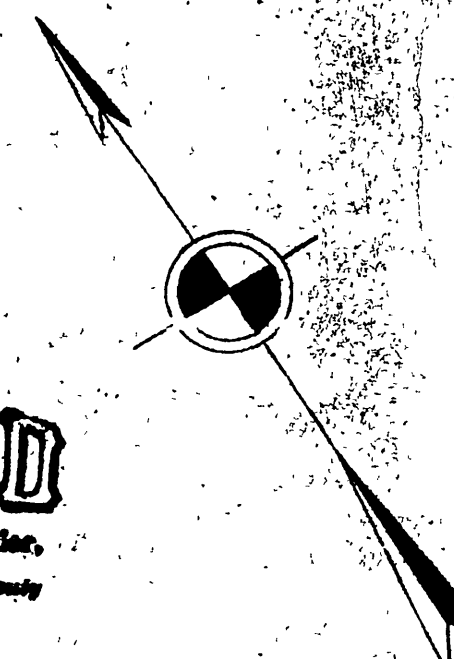
MAP OF THE RESUBDIVISION OF THE DAVIDSON SUBDIVISION
