 County. Courses 7 and 8 are of this survey. Courses 10
 to 19 are from a survey made by K. Sanborn. The area
 of lot 3 was calculated with a planimeter.

 ent tracts of Land which it represents as divided into lots.

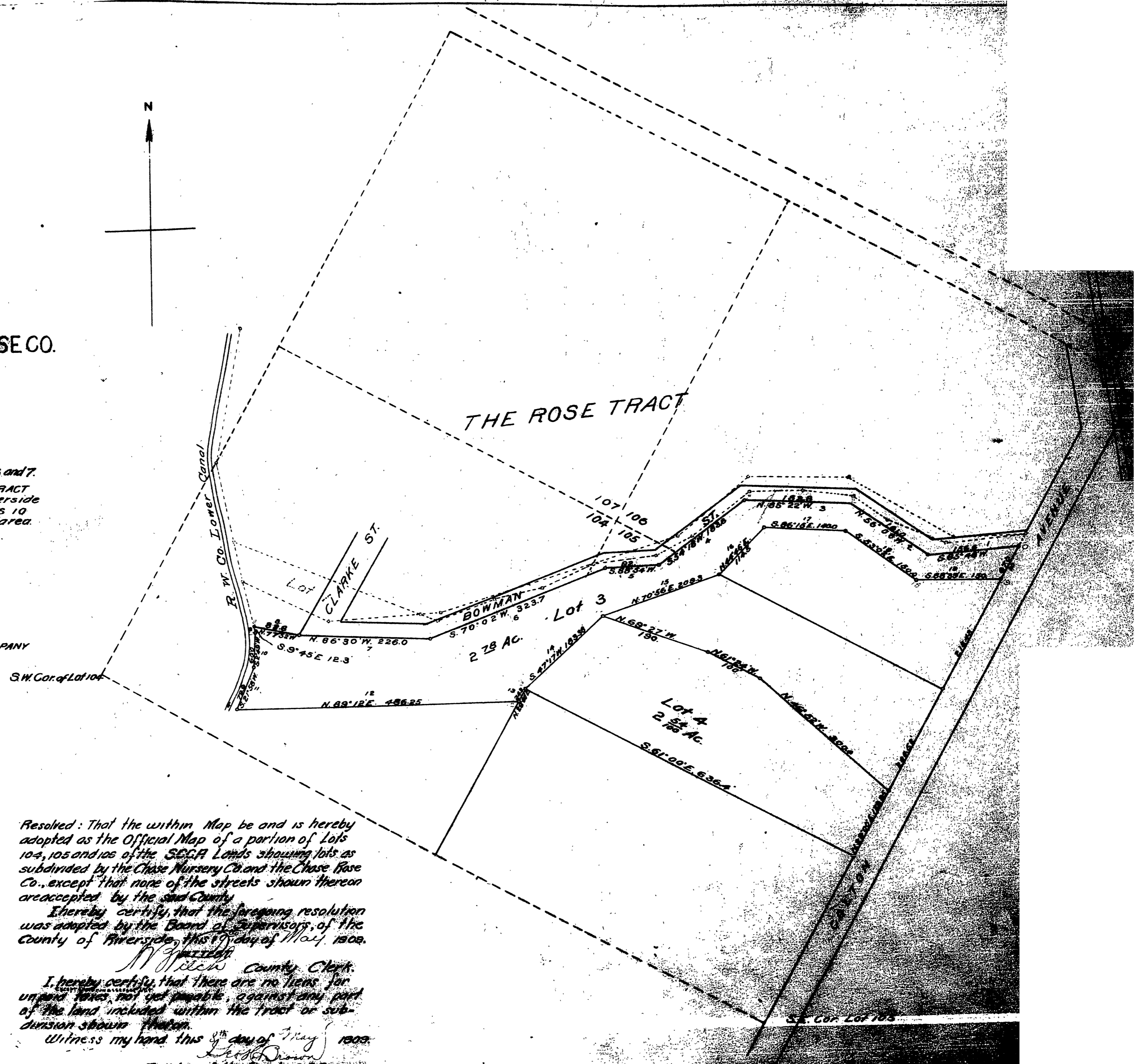
