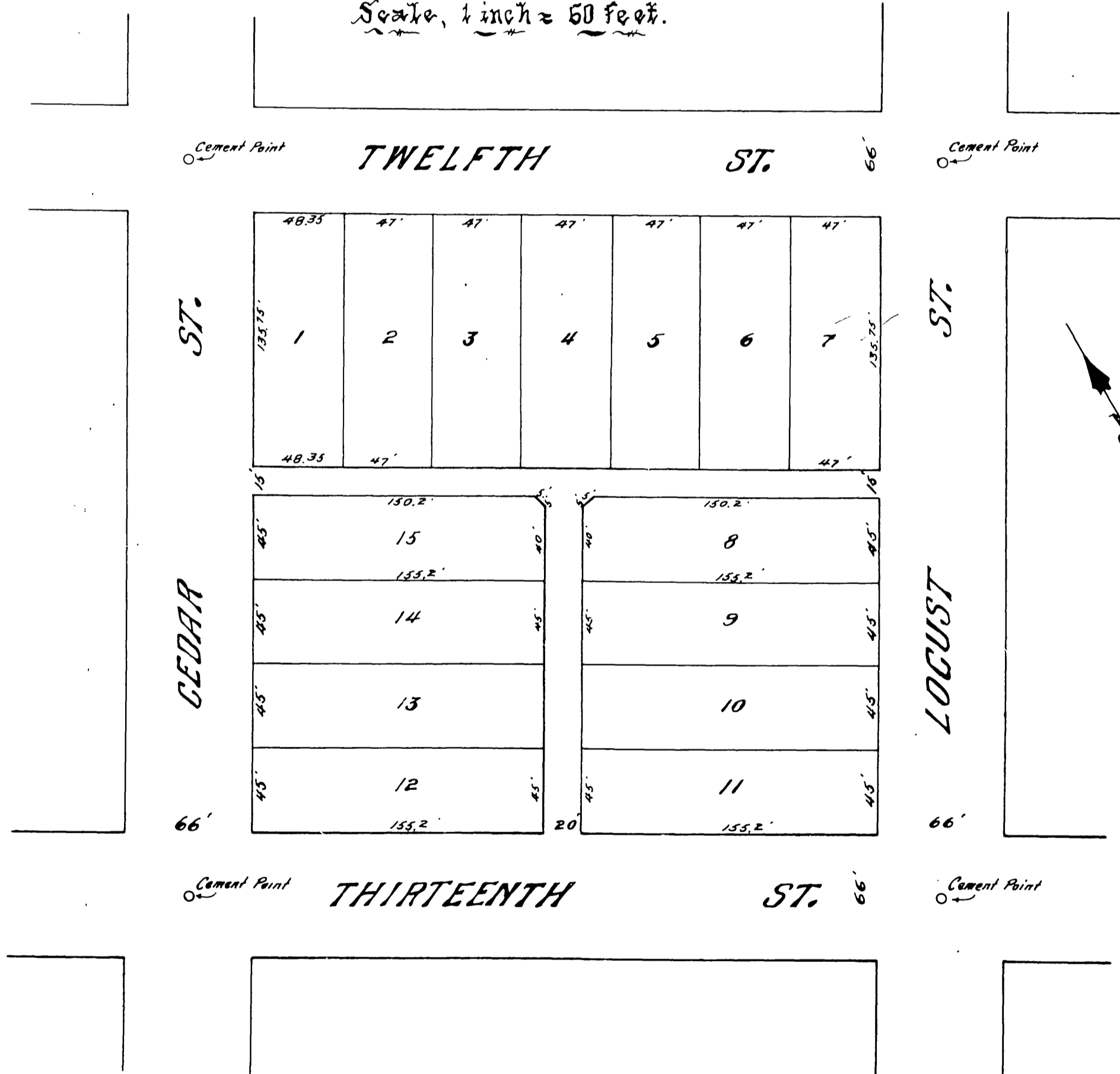


MAP OF THE ERDICE SUBDIVISION
