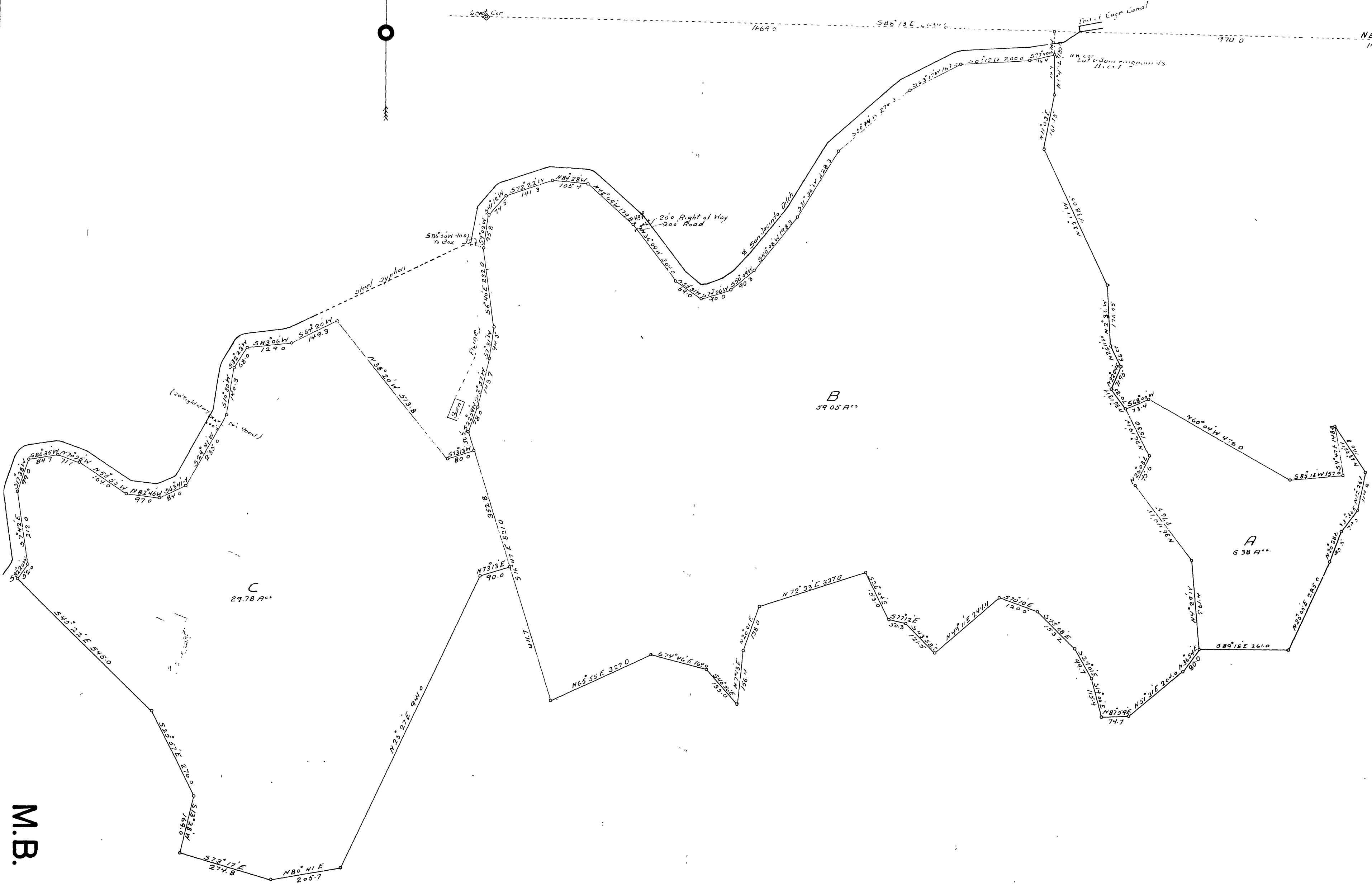


MAP
