

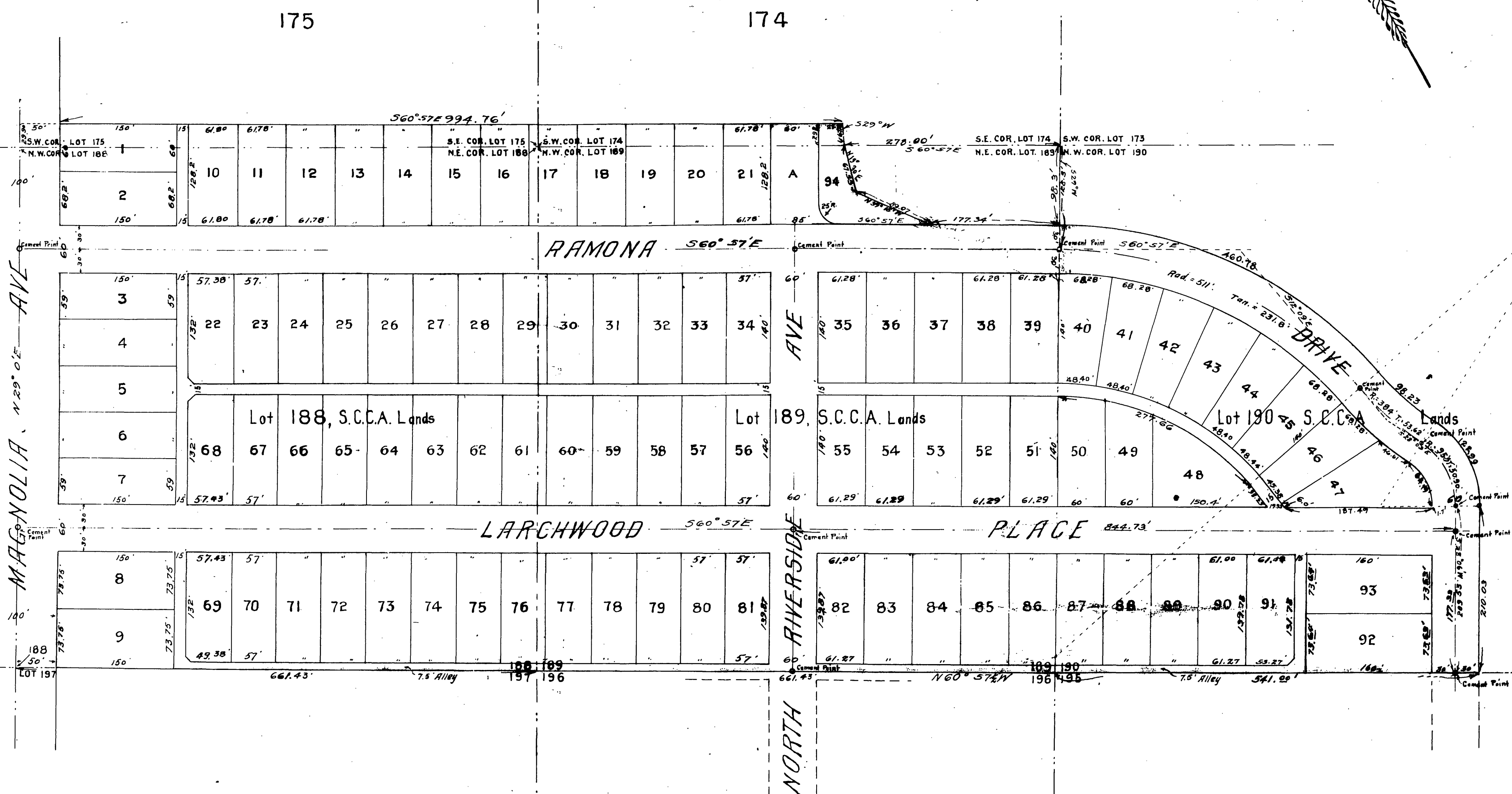
# MAP OF BRENTWOOD PLACE TRACT
