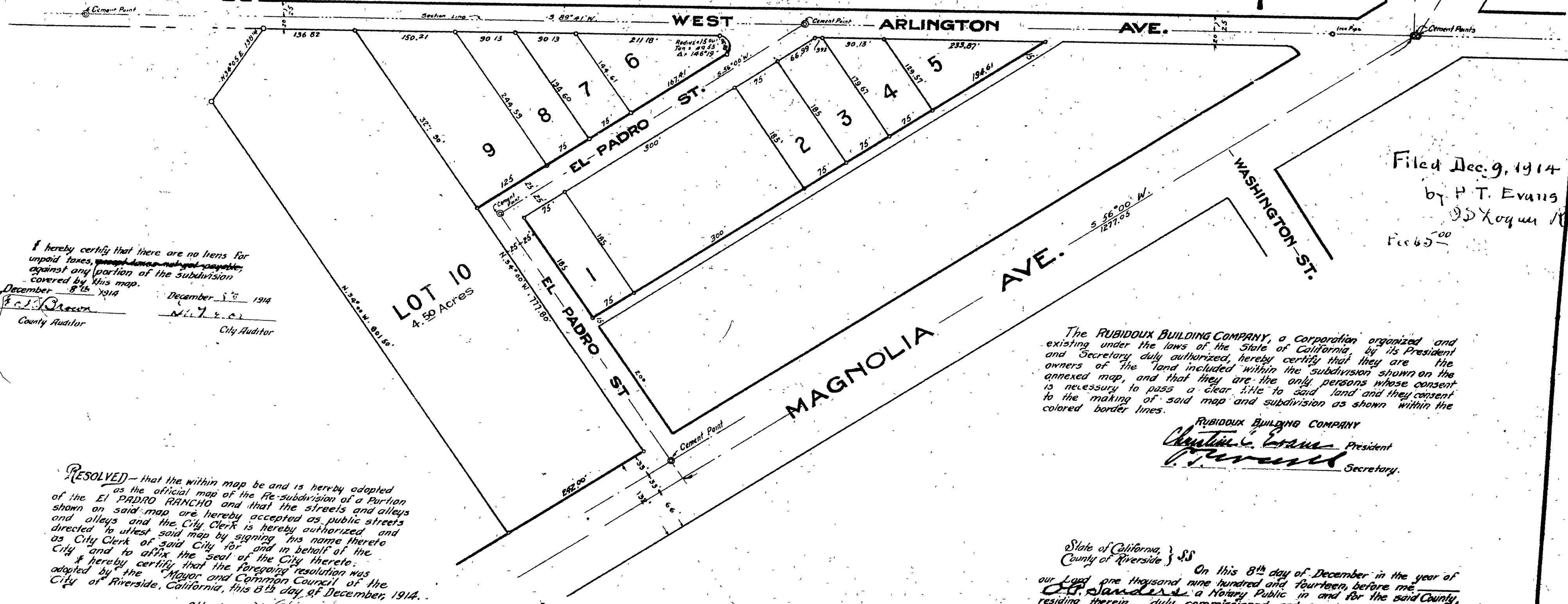


MAP OF THE
