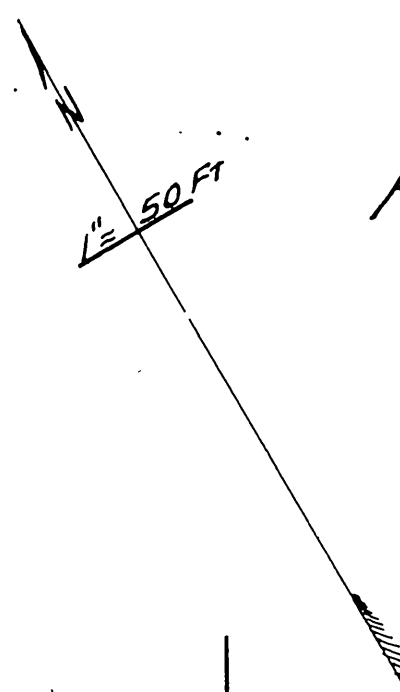


MAP

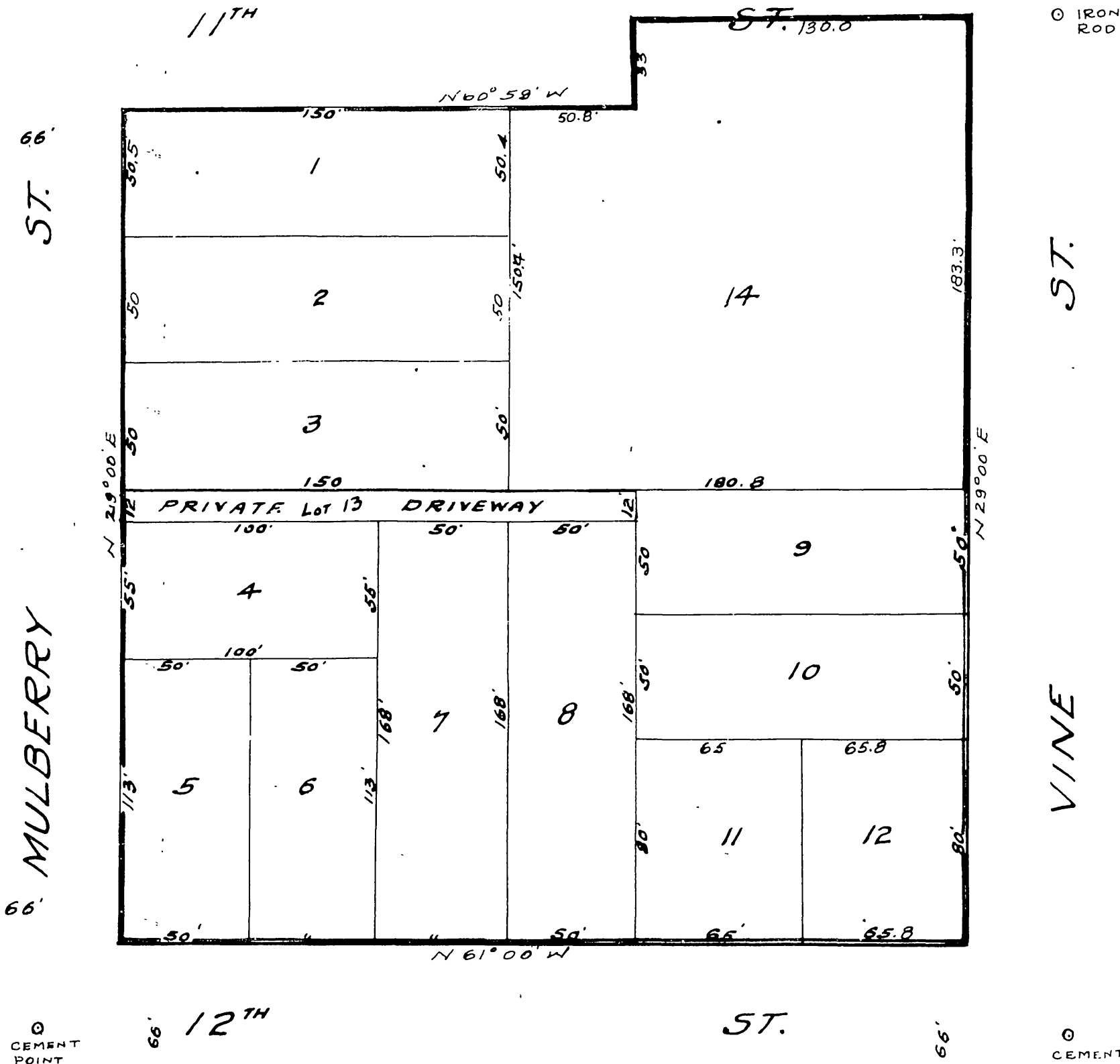
