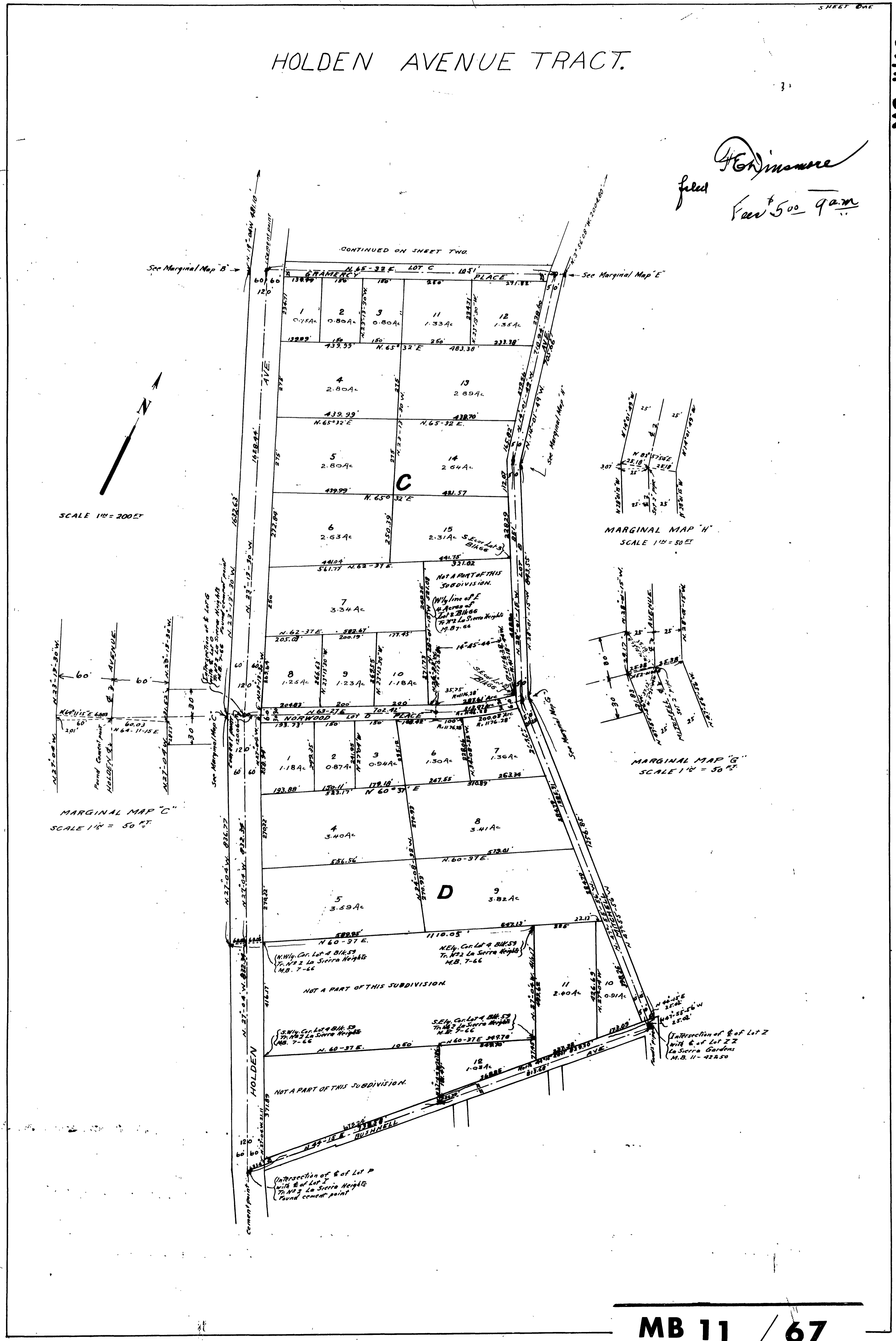

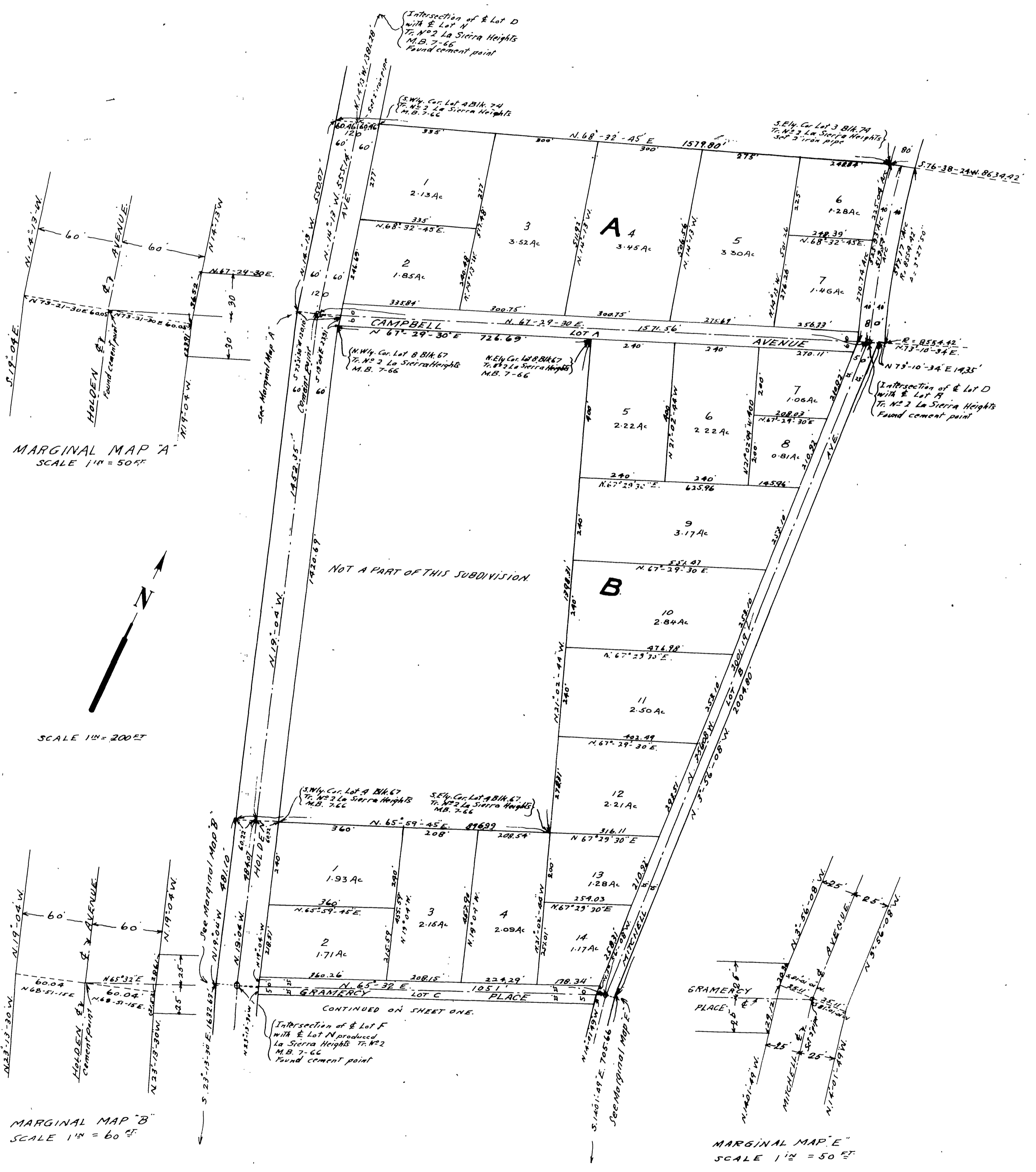
MARGINAL MAP "C"
