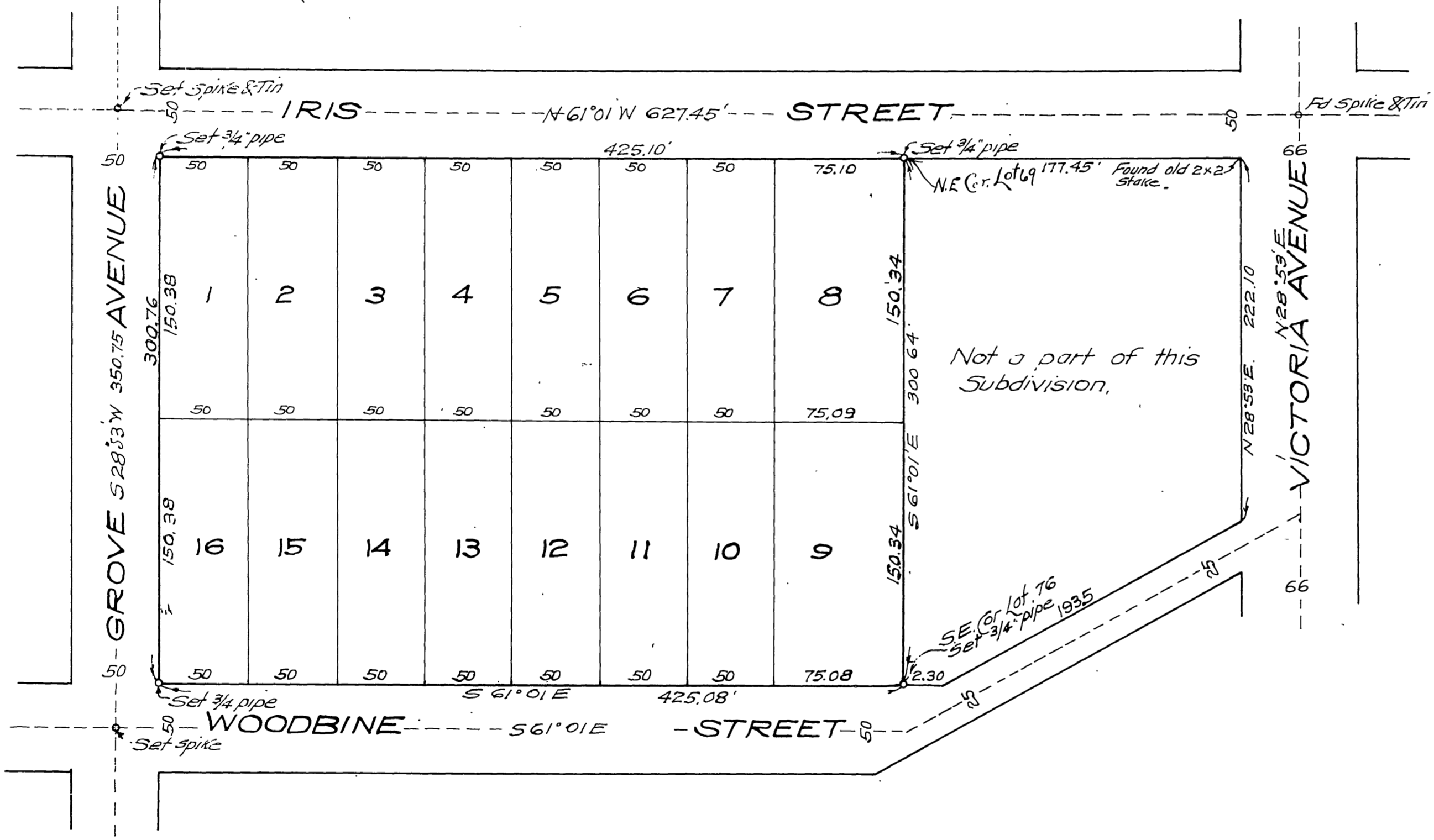
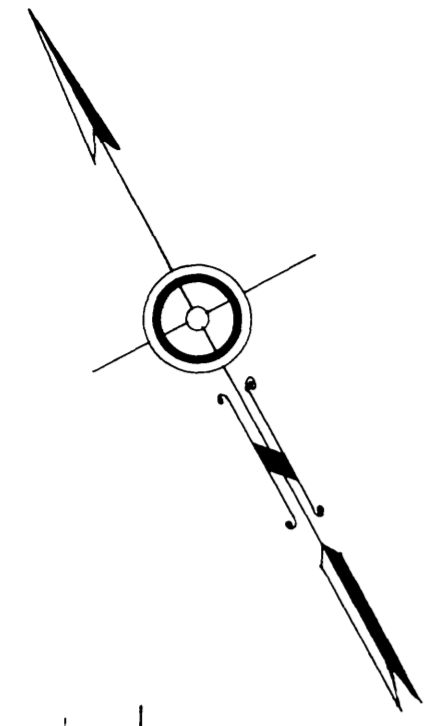


MAP OF IRIS SQUARE
