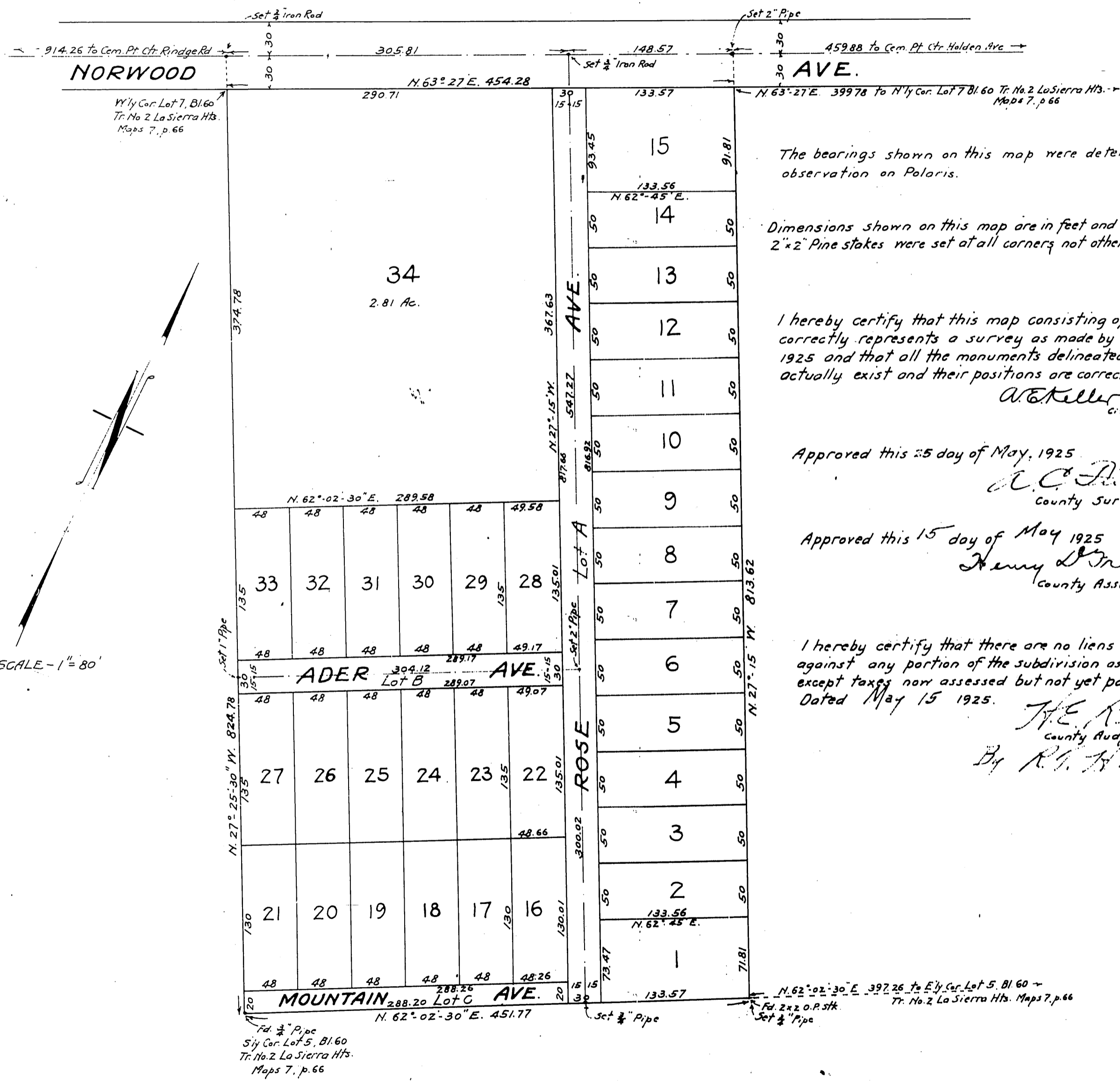


ADER'S LA SIERRA SUBDIVISION
