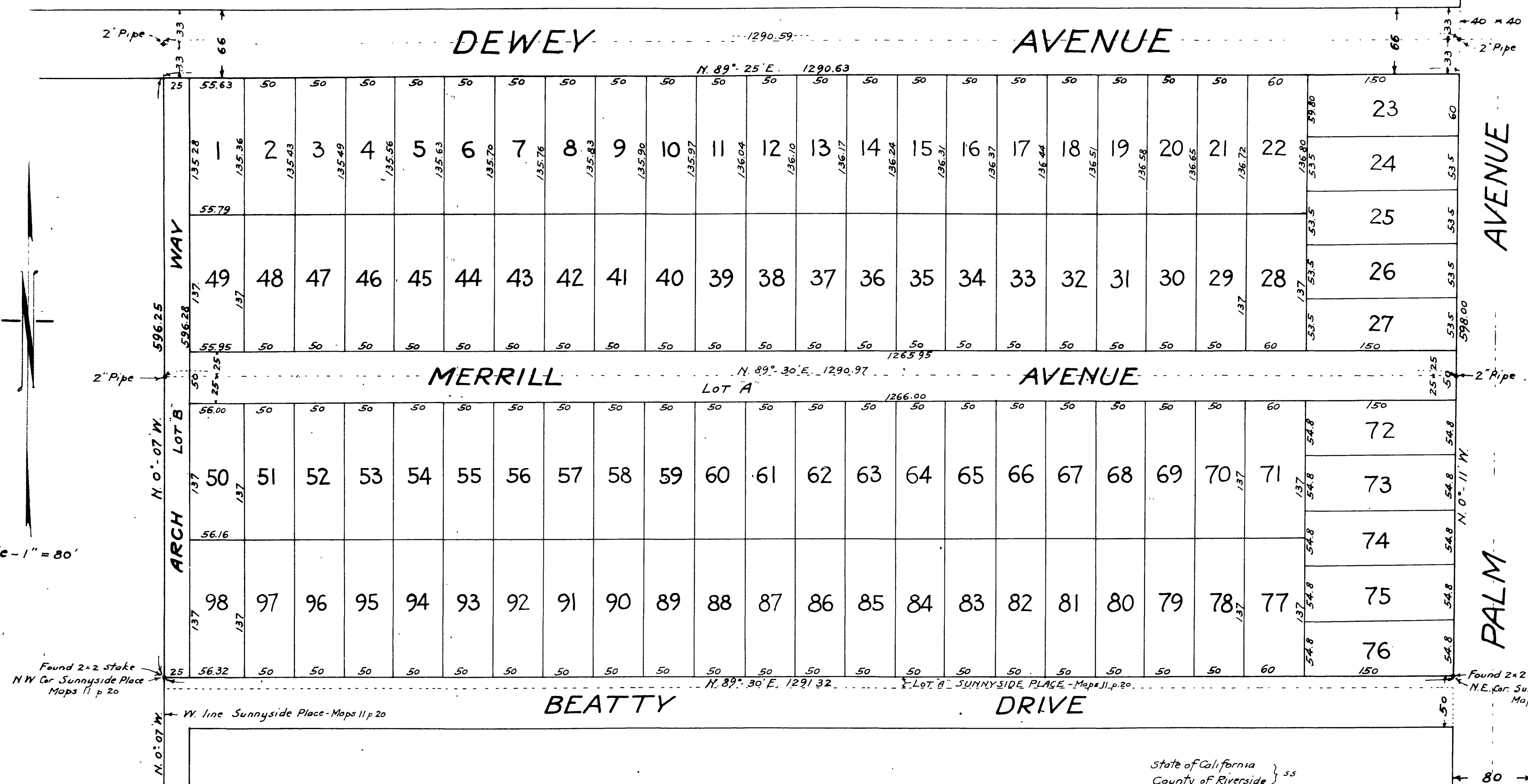


VENETIAN SQUARE
