

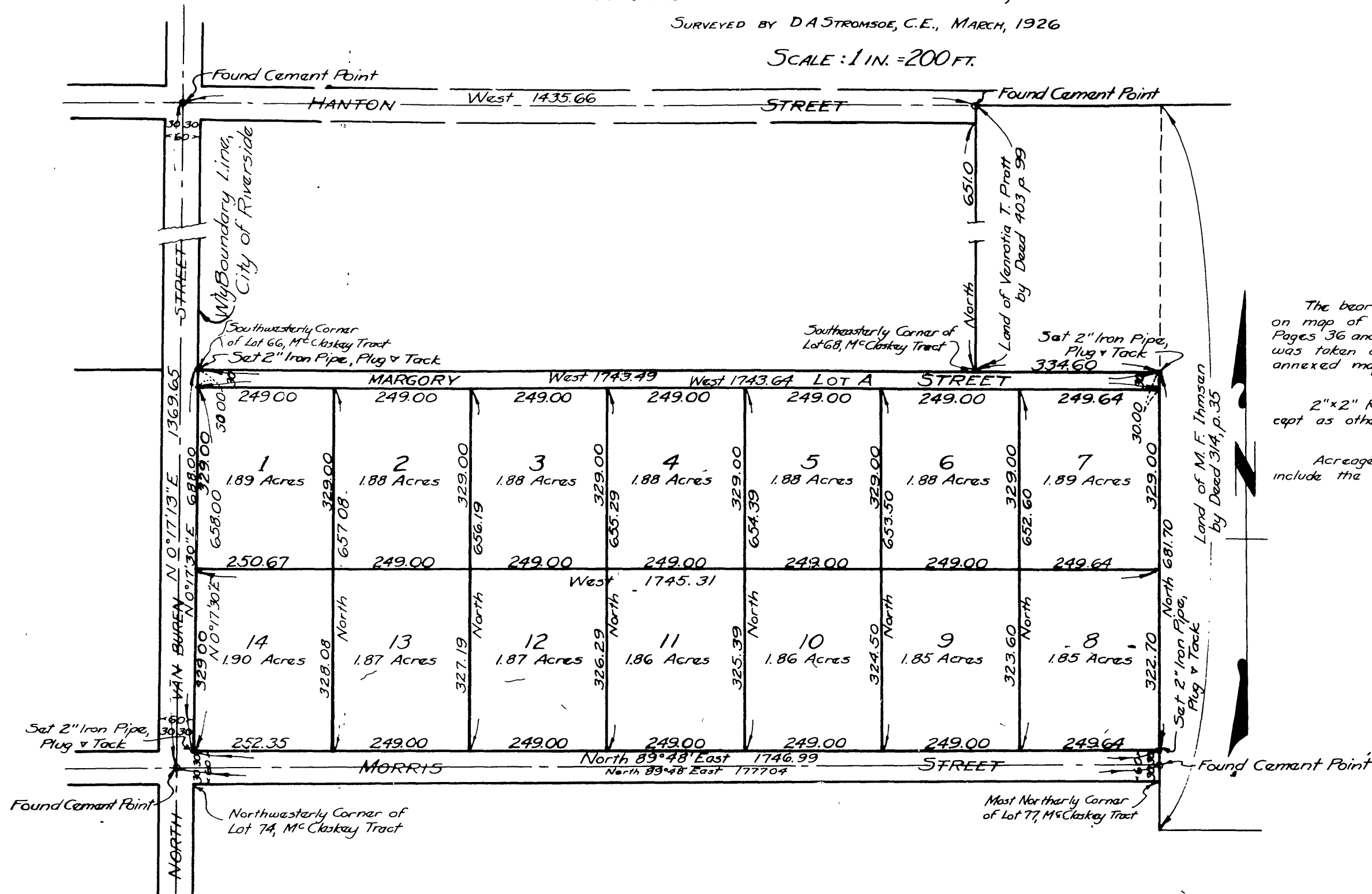
MC CLASKEY TRACT No. 2
