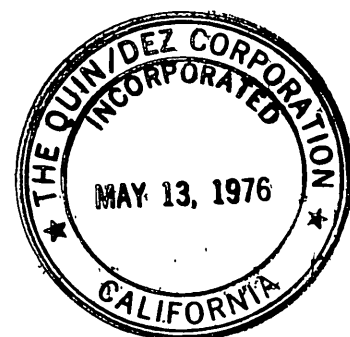

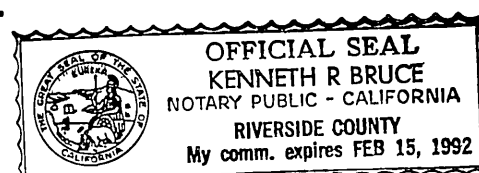

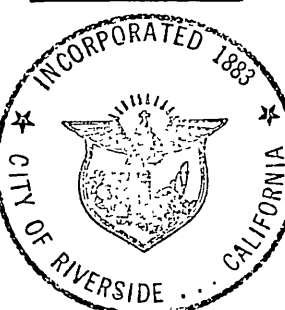

## SOIL REPORT

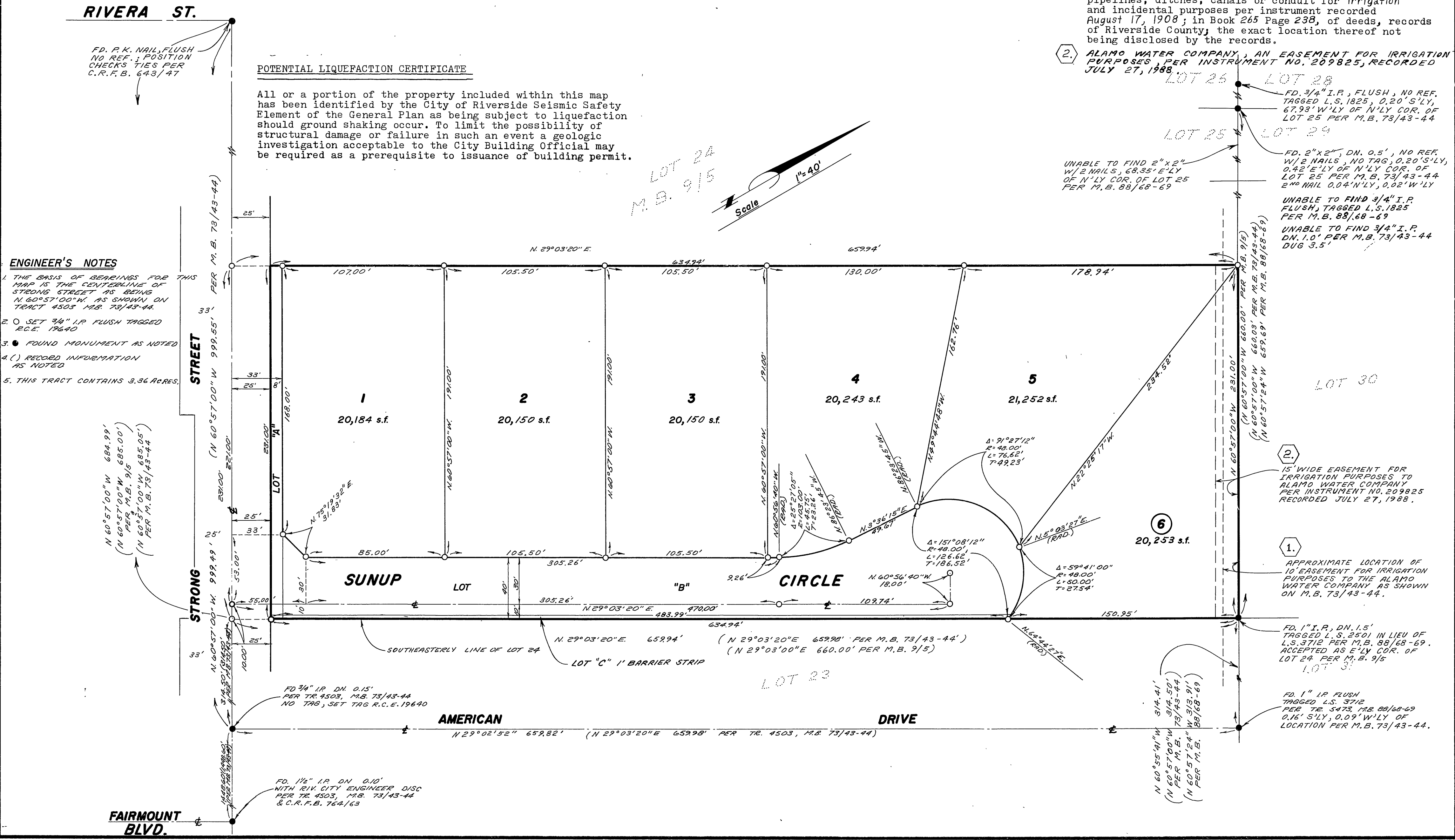
A Preliminary Soil Report was prepared by Lynn A. Terry & Associates, on March 23, 1988, as required by the Health and Safety Code.

## POTENTIAL LIQUEFACTION CERTIFICATE
