35TH ANNUAL RIVERSIDE COUNTY PEACE OFFICERS' MEMORIAL CEREMONY & RUN

Riverside, CA – On Monday, May 21, 2018, Riverside County law enforcement agencies and surviving family members will remember those peace officers who have died in the line of duty at a solemn ceremony. It will take place in front of the “Safe in His Arms” memorial statue, at 4102 Orange St., in Riverside, beginning promptly at 6:15 p.m. The public is invited to attend the ceremony and participate in the moderate run/jog which will begin prior at 5:45 p.m., at the corner of Orange Street and 12th Street. Registration is **NOT** required for the run and is open to everyone of all ages and abilities.

The ceremony, steeped with police service traditions, will recognize those who died in service prior to 2018. Fortunately, Riverside County did not see the tragedy of a Fallen Officer this past year, but the memory of losing Jose “Gil” Vega and Lesley Zerebny of the Palm Springs Police Department in 2016 still rests in the forefront of all our hearts.

Senior law enforcement officials taking part include: Master of Ceremonies - Chief Jeff Wade of the Blythe Police Department, Riverside County Sheriff-Coroner Stan Sniff, Cathedral City Police Chief Travis Walker, Corona Police Interim Chief James Patton, Palm Springs Police Chief Bryan Reyes, Beaumont Police Chief Sean Thuilliez, and many other agency leaders, and city and county government officials from all over Riverside County.

The “Safe in His Arms” memorial statue displays the names of twenty-one Riverside County Sheriff’s Deputies, sixteen Riverside Police Officers, nine California Highway Patrol Officers, eight United States Border Patrol Agents, four Palm Springs Police Officers, two Cathedral City Police Officers, and one each from the Corona Police Department, California Bureau of Narcotics Enforcement, Union Pacific Railroad Police Department and the California Department of Corrections & Rehabilitation-Norco.

Join us as we honor those who have laid down their lives for the community members of Riverside County, and to support the families and friends they left behind.

There will be free parking available in the parking structures located at 3535 12th Street and 4080 Lemon Street.
