



## FORTUNE TELLERS PERMIT — INFORMATION SHEET —

### **GENERAL INFORMATION**

The City of Riverside Municipal Code 9.42.015 has the following Fortune Tellers Permit requirements.

- A. No person, association, partnership or corporation shall conduct, operate or advertise for an establishment in which the practice of fortunetelling and occult arts is carried on for pay, compensation or gratuity without obtaining and maintaining in effect a license as required by this chapter. (SEE EXEMPTIONS UNDER 9.42.020 - EXEMPTIONS)
- B. Any person desiring to obtain a Fortune Tellers Permit shall first file with the Police Department an application in writing upon a form as prescribed by the Chief of Police and accompanied by a non-refundable application fee in such amounts established by resolution of the City Council.

### THE FOLLOWING STEPS MUST BE COMPLETED TO OBTAIN A FORTUNE TELLERS PERMIT WITHIN THE CITY OF RIVERSIDE:

Review Riverside Municipal Code 1 Chapter 9.42.015

Riverside Business Tax License (Copy of current license)

Application: Completed in full (Including Property Owner Acknowledgement/Notary)

Valid Photo Identification (Color copy)

**Pre-Application Form** (Zoning Approval)

Copy of Lease/Proof of Ownership (Rental Agreement/Mortgage, etc.)

Submit items 3-6 along with the application. Application processing may take up to 90 days. Once the application has been approved, the Fortune Tellers Permit will be issued.

#### THIS PERMIT MUST BE RENEWED EVERY YEAR

There is no grace period for renewals. Renewal Applications must be recieved before the expiration of your license or you will have to re-apply and pay any applicable fees. All fees are non-refundable.

Complete applications will be accepted by appointment only (walk-ins will not be seen).

Riverside Police Department shall complete an investigation of the qualifications and moral character of the applicant and either grant or deny the permit within ninety (90) days after the submission of the completed application; provided, however, if good cause exists, the Riverside Police Department may extend the period of investigation for an additional thirty (30) days, provided the applicant is mailed notification or verbally notified that the investigation has not been completed.
