

# RIVERSIDE POLICE DEPARTMENT PAWN BROKER/SECOND HAND DEALER PERMIT INFORMATION SHEET

### **GENERAL INFORMATION**

### The City of Riverside Municipal Code 5.90 has the following Pawn Broker/Second Hand Dealer Permit requirements.

- A. No person shall own, operate, or manage any pawnshop establishment in any location within the city without first having obtained a pawnshop business establishment permit from the chief of police. No person shall own, operate, or manage any secondhand dealer establishment in any location within the city without first having obtained a secondhand dealer establishment permit from the Chief of Police.
- B. Any person desiring to own or operate a pawnshop establishment or secondhand dealer establishment must first obtain the licenses, certificates, and permits described in sections 5.90.030, 5.90.040, and 5.90.050 in order to obtain a pawnshop business establishment permit from the Chief of Police.

**Submit items 3-9 along with the completed application.** Application processing may take up to 90 days. Once the application has been approved, the Pawn Broker/Second Hand Dealer Permit will be issued.

There is no grace period for renewals. Renewal Applications must be recieved before the expiration of your license or you will have to re-apply and pay any applicable fees. **All fees are non-refundable**.


