## CELEBRATING 10 YEARS of Public Benefits Programs

Riverside Public Utilities is proud to have offered 10 years of Public Benefit Programs. Our programs have provided customers with millions of dollars worth of incentives and rebates for making their homes and businesses more energy and water efficient.

### Solar

Riverside is a leading solar Utility in the nation. More than 143 kilowatts of solar energy projects were installed last year, raising the City's total to 790.59 kW.

### Tree Power

Customers planted over 9,625 shade trees this year utilizing our Tree Power shade tree program. Since 2001, the program has planted over 68,000 trees.

### Education

Riverside's award winning education program includes interactive classroom participation and important conservation messages about energy and water. This program reached 2,572 students last year, and has educated 35,572 students since its inception.

### Energy Star

We've given back more than \$5.8 million to customers who purchased energy-efficient Energy Star rated appliances, doors, and windows. We are currently offering up to \$200 cash back for purchasing new qualified refrigerators!

### Air Conditioning

Over \$1.3 million dollars in rebates were provided to 3,000 residential and business customers who have taken advantage of our program. Our rebate incentives now offer 10% of the total project cost to install new cooling systems - up to \$750.

### SHARE

Since 1999 nearly 40,000 neighbors in need have been assisted by this program at a cost of over \$5.5 million.

*Conservation is a key element that allows Riverside Public Utilities to offer high quality, reliable energy and water services at the lowest possible rates to benefit the community.*




